Please note that there are advantages and disadvantages to graduating under these bills. While a student may graduate with classmates and receive a regular high school diploma, they may sacrifice important learning opportunities that are necessary to succeed in higher education and employment. Students who graduate under these bills m not be eligible to apply directly to a California State University or University of California school. However, through California Community Colleges the student may gain entry into these university systems.

The right to a 5 th year of high school applies even if the student will be 19 years old during that additional school year. The student will be allowed to remain at the local high school and will not be required to transfer to a continuation school, independent study program, or adult school to complete the 5 th year.
