



**Verification of Identity and/or School Attendance**

**Learner's Permit Applicants:** Maryland State Law requires all applicants for a learner's permit, under the age of 16, to demonstrate acceptable school attendance in the prior school semester. To verify school attendance, School Official or Home School Coordinator must **complete Sections B and D** of this form.

**Verification of Identity:** This form may also be used to verify the identity of an applicant named in Section A. To verify the applicant's identity, School Official or Home School Coordinator must **complete Sections C and D** of this form.

This form applies to public, private and home school students.
