#### II. Old Business

- Future Development of St. Brigid School-Chuck gave a quick update letting all members know that he has been asked to serve on the town committee that is looking into the best way of using the St. Bridgid property to benefit the community
- **Possible Annual Music Event** Javier said that planning for a summer 2023 event would be ideal. Chuck suggested that it would be worth exploring outdoor venues for this event, including a possible St. Brigid outdoor amphitheater.

  - ✓ Murals on Private Property WH residents don't have to get a permit to put up a mural on a private property however, reaching out to immediate neighbors is encouraged

-creating a policy regarding public art displayed at the Town Hall including criteria for accepting art donations, permanent installation items, semi-permanent items with a set period of time, and rotating displays

-electronic check-in displays in front of the busiest offices

-a cohesive art hanging/display system

-murals could break up the monotony and help diversify the art spectrum

-no art displays in the Auditorium

-history of WH related displays concentrated in one spot
