1. You may park a truck and/or erect a temporary tent and/or use such furniture authorized in writing by the Town of Hamden on the event day, no earlier than 1 hour before the event begins, on a space designated by the Town of Hamden. You may hand out such items approved by the Town of Hamden and adhere to the Event Guidelines. After the event ends you agree to remove your car, furniture and appurtenances from Town Center Park and clean and sweep the area. No tent shall be staked in the bituminous concrete.
2. You agree to participate and be present on the event date (unless the event is cancelled by the Town). Foul weather cancellations are made as soon as possible. If you cannot attend the event, please contact the event manager well in advance to let them know.
3. All tents are to be staked into the grass.
4. The Town of Hamden reserves the right to cancel licenses, events, and invitations to participate in the Hamden Pride Event.
5. You shall indemnify, defend and hold harmless the Town of Hamden, the Hamden Housing Authority, the Hamden Board of Education and Hamden Public Schools, their agents, representatives, and employees, officers, employees, agents and assigns from any and all claims arising from your use and occupancy of the Town Center Park Market.
