The Washington County Board of Education met in Regular Session at the Washington County TEL Center at 6:00 p.m. on the 21st day of MARCH, 2022 with the following members present:

Board Chair Curtis Hamilton led the pledge of allegiance and board member Jeremy Thompson read the mission statement. Mr. Hamilton welcomed all in attendance and reminded the audience that March is Women's History Month.

Recognition

WCHS library media specialist Mrs. Nicole Wilson, who serves as the school's Educators Rising sponsor, introduced the students, and Dr. Cochran presented them with certificates for their accomplishments. Lilly Swift was absent from the recognition.

Legislative Liaison Report

Mr. Thompson reported that legislative session ends on April 14, 2022. As of this weekend, the status of a few bills we are watching are reported as:

- HB1 Budget Bill passed House and Senate Now in conference committee to agree to a final bill
- HB63 SRO Bill passed House, passed Senate Committee, awaiting full Senate vote
- SB1 Superintendent, Principal Selection, SBDM passed Senate, had second reading in House
- SB6 Name, Image, Likeness Bill passed Senate and House and was signed by the Governor on March 9, 2022.
- HB51 Mask Mandate Bill passed House, Sent to Health & Welfare Committee has not been called yet for committee hearing.
- HB121 Public Comment Period at Board meetings (15 mins) passed House & Senate, but back to House with amendments.

General Fund:

General fund received \$8,628,605.95 in revenue and spent \$6,406,138.84 in expenditures. We have an increase in supplies both general and custodial, electricity, diesel fuel, tires and lube, and bus repair parts.

Special Revenue Fund:

Year-to-date expenditures for salaries and fringe are \$1,641,877.74 and operational expenditures are \$1,297,075.73.

District Activity Fund:

Year-to-date expenditures are \$74,836.75.

Student Activity Fund:

Year-to-date expenditures are \$127,837.48.

Capital Outlay Fund & Building (FSPK) Fund:

We received \$77,120 in capital outlay funding and \$316,644 in state match FSPK funding and \$804,082 in local property tax. This will be used to offset the debt service.

Construction Fund:

Year to date we spent \$1,100,911.27 in construction funds.

Debt Service Fund:

Year-to-date principal and interest paid on debt is \$1,231,121.94.

Food Service Fund:

Total year-to-date receipts are \$917,501.05 and expenditures are \$821,387.01.

Day Care Fund:

Total year-to-date receipts are \$75,542.69 and expenditures are \$24,360.70.

Scholarship Fund:

Total expenditures this year is \$2,000.
