COMPREHENSIVE NEEDS ASSESSMENT (CNA) PROCESS

Dr. Johnson provided a review of the CNA process, using a PowerPoint presentation entitled, "Developing the Comprehensive Needs Assessment".

- Today, we are laying the groundwork on a district lens.
 - Establish a school-wide planning team. Campuses will do the same with a campus level team. Should be diverse with various departments, parents,
 - o Identify the vision that will cause change to happen to improve student performance.
 - o Create the school profile; who are we serving; who are in our profile and identify data.
 - Analyze the data. Look critically at what this means for us and how to get to the next level. How can we get better? Find the gap between the ideal step and where we are now.
- This committee will measure things we do as a district.
- The TEA Strategic Priorities Established by the Commissioner.
- In line with policy makers and aligned to what we need to do; build capacities, and partnerships within the community
- We are using data to support what the goals should be to set priorities.
- The driving forces that impact the plan were reviewed.
- Any time funds are expensed, the campuses us their CIP to target their goals and tie in the funds to be used.
- Process ends with our program evaluation.
- These eight indicators are in the plans (DIP and CIPs).
- The state has established three elements.
 - o District Improvement Plan
 - o Campus Improvement Plan
 - o Family & Community Engagement Plan
- Annual review May is when we adopt the new plan for the next year.
 - o The District Improvement Plan is presented to the Board of Trustees at that time.
- The goal is to increase student achievement.
- The CNA Survey window: December 16, 2019 through January 31, 2020.
