- Facilities or equipment not listed are not available for rental.
- Other terms and conditions may apply; refer to policy C-4.
- Deposit amount is per rental agreement. Only one deposit per playing season is required for field and ground rentals by youth recreation groups.
- Fees are on an hourly basis unless otherwise stated.
- Rental fees generally include the cost of a custodian provided the event occurs during normal working hours and there are less than 50 participants. If the event extends beyond normal working hours or the event occurs on a weekend or holiday, additional personnel charges will be assessed at the rate shown.
- NC means no charge and NA means not available for this category.
- Neighborhood Community Councils are permitted to use school facilities at no charge provided arrangements are made through the Rental Coordinator.
- Miscellaneous charges are for those services not included in the basic rental fee for buildings, fields, or grounds. These fees are necessary to offset the costs associated with the operation, maintenance and/or replacement of the item listed and cannot be deducted from the rental fee.
- Refrigerated air-conditioning systems are not operated outside of normal school hours. Cooling will only be provided at the user's request and upon payment of the additional fees. Site with evaporative systems are permitted to operate as needed after normal school hours.

10. The fee for rental of the commons or foyer area for Government Elections only will be \$35 a day.
11. Classroom rentals for government entities or non-profit children's groups will be at a rate of \$9 per hour.
