

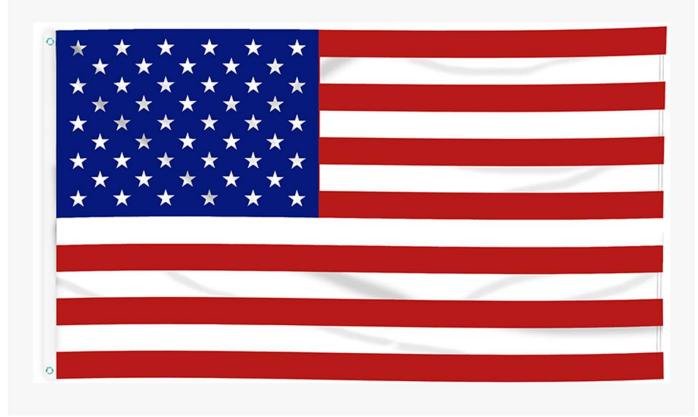

- Building "H" CMU for Creek Café is topped out; Soffit sheetrock is being hung; Flooring has commenced and will be completed mid-December; Material delays are occurring with roll-up doors, light fixtures, electrical outlets, sinks, and water closets; OSF Dates same as above
- Building "G2" Addition: Sewer is complete; Slab is placed; Masonry has begun; Partial structural steel has arrived on site, remaining to arrive late-December; Roof insulation is on site; Overhead work is scheduled to begin in January

- Site Athletics: Dugouts are demolished, new building pads are complete and foundations for dugouts to be complete mid-December; Concession building is demolished; Site contractor is scheduled to install building pad for Field House prior to January 1st and Concession Building the next week; Dominion Energy coordination meeting occurred on November 30th; Dominion Energy informed team that delays have occurred on their end and currently the new transformer serving these 2 buildings is a year out; MBK needs new transformer to be set in May of 2022; Dominion Energy and JCS are looking at alternative solutions; BOE approved donation of \$340,000 for video scoreboard, MBK Amendment No 03 is being routed and the board is schedule to arrive in Q2 2022, shipping date will be shared when received





- JE Dunn job trailer is expected to arrive in January; Superintendent is on site daily


