SUPERINTENDENT'S UPDATE

Dr. Scarsella delivered an update on the meeting of the Portrait of a Graduate strategic planning committee on April 6 where the members met to discuss the final design of Portrait of Graduate graphic with our consultant from HYA.

He recognized Assistant Principals Week which was earlier in April. He also recognized April as Occupational Therapists month and thanked the Palos 118 OT (occupational therapists) team for their efforts. Dr. Scarsella also thanked the District's transportation staff ahead of their day of recognition on April 26.

Dr. Scarsella recognized Palos South Assistant Principal Meagan Doornbos who has been named a recipient of an Award of Excellence in the Administrator category as part of the 2022 Distinguished Service Awards Program sponsored by the Illinois Chapter of the National School Public Relations Association (INSPRA).

Palos East, South, and West were recognized for their successful collection of donations for the humanitarian relief efforts in Ukraine and Palos West for their aluminum tab collection for the Ronald McDonald House.

COMMITTEE REPORTS

FINANCE COMMITTEE

Mr. Pizur reported that the Finance and Facilities Committee met on April 12 where Justin Veihman, Chief School Business Official, outlined plans for summer projects that include renovation of the Palos South Applied Tech Lab and replacement of interior doors. Mr. Veihman also recommended the disposal of surplus property. The committee reviewed next year's budget and discussed long-term financial planning. Mr. Veihman reported that the estimated budget deficit for next year is approximately \$1.5 million. Mr. Veihman informed the committee the deficit was due to several factors including the elimination of federal ESSER funds, several years of stagnant property tax revenue growth, and additional staffing required to provide state-mandated and essential services. Dr. Scarsella and Mr. Veihman engaged the committee in a discussion about how this continued trend will impact the school district's finances in the future.
