1. Term- Three years, July 1, 2020 – June 30, 2023.

- 2. The salary for the Superintendent shall be \$133,093.00, payable in equal installment or the Corporation's normal payroll schedule. Compensation increases will be based upon the average percentage provided to certified teachers and that of the administrators. In addition, the Superintendent shall receive all fringe benefits outlined in this Addendum, along with any fringe benefits provided to teachers in the master contract.
- 3. A Work year of 240 days with annual entitlement to sick days, personal business days, and bereavement leave per the teacher master contract.
- 4. The Board shall review the Superintendent's contract annually by December 1 prior to the upcoming contract year, take action determining whether or not to extend the contract for another contract year by December 31st of the same calendar year. If the Board does not take these actions, the contract shall be automatically renewed and the term extended for an additional year. In addition, the Board, will on an annual basis, review the Superintendent's performance in accordance with policy.
- 5. The School Corporation agrees to pay the mandatory contribution to the Indiana State Teachers' Retirement Fund.
- 6. Family plan medical insurance coverage of the same type and with the same provider as that approved for teachers. The Superintendent shall be responsible for paying the percentage of premiums equal to that paid by long-term certified staff with the Board responsible for the remainder of the premiums. Dental coverage paid for by the Board as provided for teachers or as otherwise limited and/or prescribed by state law. - 8. The Board shall pay \$7,000 per contract year into a 401 K account, for the benefit of the Superintendent, in accordance with all applicable law and account rules. Such payments shall be credited to the Superintendent's account in the same manner as for other School Corporation participants.
- 9. The Board encourages the Superintendent to participate in professional development. The Board will reimburse the Superintendent for any such expenses including dues and memberships to professional organizations to the NSBA, ISBA, ASCD, IASBO, IAPSS, the Study Council, IU
