On April 28, 2016, bids were opened for Asphalt Removal and Replacement/Asphalt Overlay and Asphalt Seal Coating at various District buildings. Sixteen (16) vendors were invited to bid. Bids from six vendors were received as shown below. The lowest responsible overall bid for all projects is highlighted.
