 - Establish a culturally diverse and inclusive educational experience that develops socio-cultural proficiency.

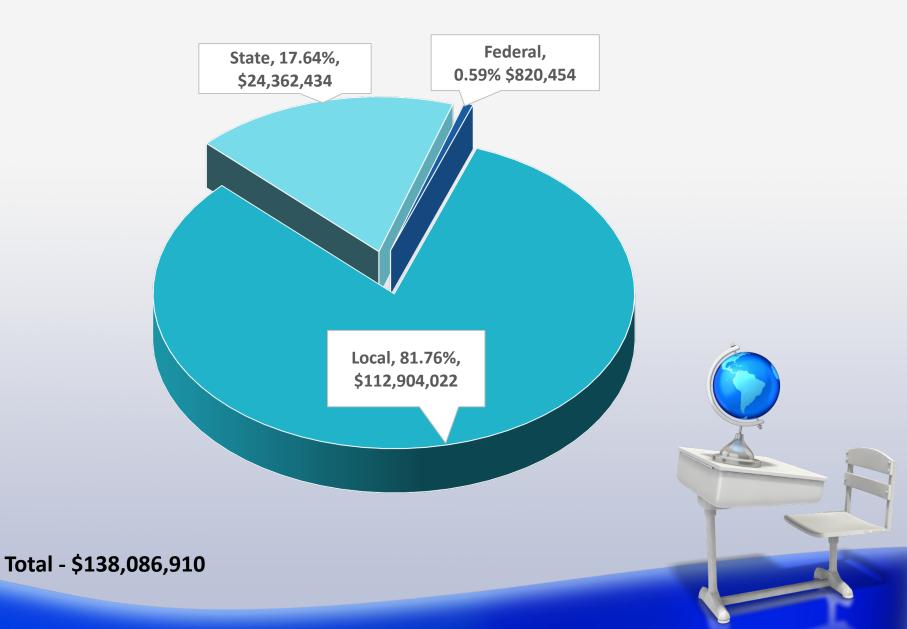
Operating Budget Development



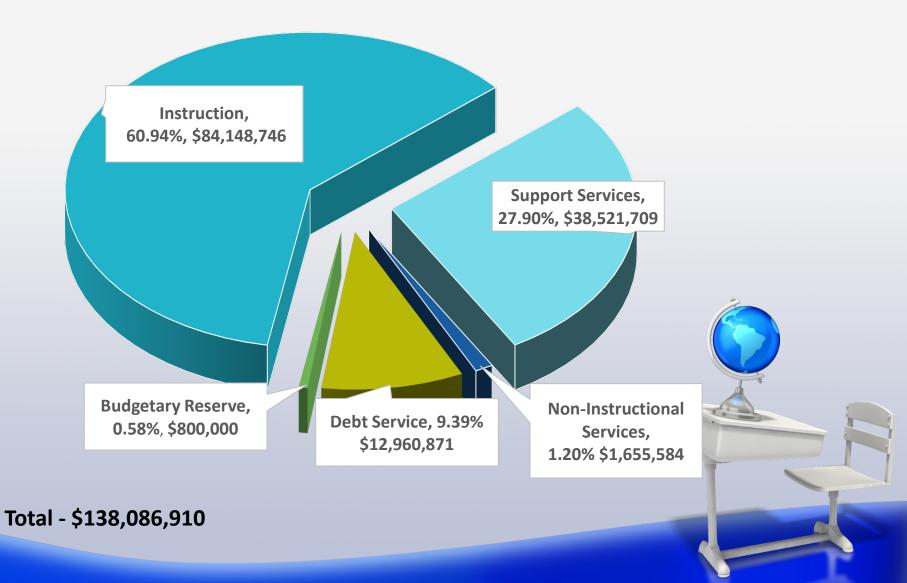

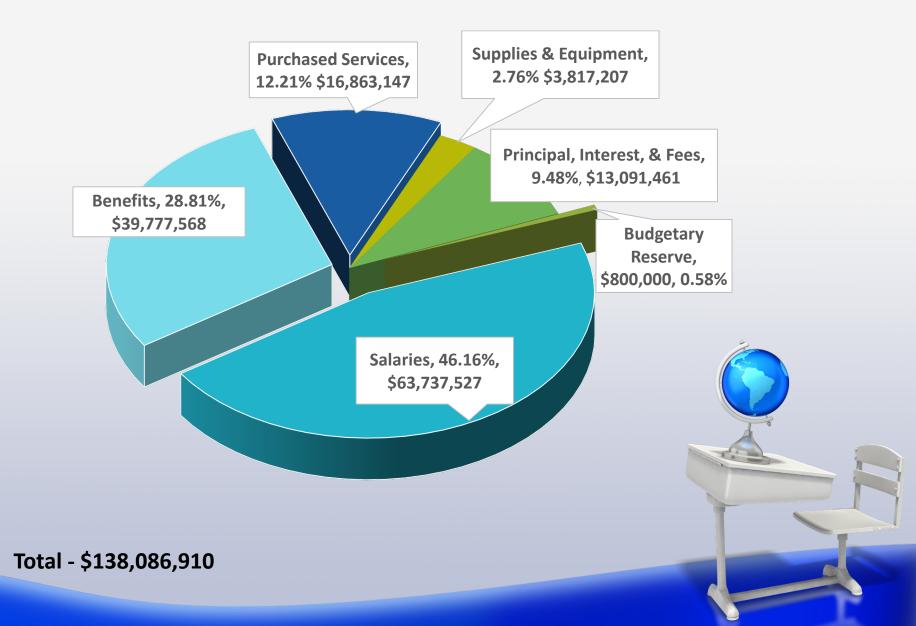




Expenditure Additions
