District Seeks Voter Approval of Operating Levy Renewal

This fall, School District 197 is seeking voter approval of a renewal of the district's current operating levy. The current levy, which was approved by local voters in 2011, will expire this year if voters do not approve a new levy.

Renewal of the operating levy <u>WILL NOT</u> increase a homeowner's property taxes.

Most school districts in Minnesota have an operating levy to support student learning. For School District 197, the current levy provides about \$1.3 million to support our schools and programs.

What is School District 197 asking for?

This fall, School District 197 is seeking voter approval of a renewal of the district's current operating levy. The current levy, which was approved by local voters in 2011 and provides almost \$1.3 million per year to support student learning, will expire this year if voters do not approve the operating levy renewal.

Ballot Language

QUESTION I proposes to renew the school district's existing referendum revenue authorization of \$224.48 per pupil which is scheduled to expire after taxes payable in 2021. The proposed referendum revenue authorization would increase each year by the rate of inflation, beginning with taxes payable in 2022, unless otherwise revoked or reduced as provided by law.

The saying goes that "bonds are for building and levies are for learning". Renewal of the operating levy will enable the school district to:

- Sustain current programs and services
- Maintain current class sizes across all grade levels

If renewed, the levy will be in effect from 2022 to 2031. Since it was first approved in 2011, School District 197 has continued to prudently invest in student learning by aligning and refining resources to avoid significant budget cuts.



Total School Property Taxes: A Comparison

For a home value of \$301,500

School District 197 has never asked to be funded at the top of the pack. Rather, the district is asking the community to continue the current level of funding with no additional tax impact to local homeowners. As illustrated to the right, for a home value of \$301,500 (the average home value in our school district), School District 197 has lower total school property taxes than most districts in the Twin Cities. Of the 42 school districts that are a part of the Association of Metropolitan School Districts in the Twin Cities, School District 197 ranks #36 in total school property taxes.

Absentee Voting

You can vote by casting an absentee ballot prior to Election Day. Absentee voting means voting by mail or in-person before Election Day, instead of at the polling location. Absentee voting begins on Friday, September 17, 2021. Any voter may vote absentee-you do not need a reason. You do not need to be registered to vote to apply for an absentee ballot. If you are not registered to vote, you will receive a "Voter Registration Application" with your absentee ballot.

To request that an absentee ballot be mailed to you: complete the Absentee Ballot Application and scan it to mary.amidon@isdl97. org OR mail it to Mary Amidon, School District 197, 1897 Delaware Avenue, Mendota Heights, MN 55118.

To absentee vote in person, you may go to any of the following locations:

Once a voter receives their ballot in the mail, they should follow the instructions carefully. Voters need to have a Notary of a registered Minnesota voter sign their envelope as a witness.


