**VIII. SUPERINTENDENT/ASSISTANT SUPERINTENDENT REPORT**

**A. Enrollment**

Student population District-wide is 1,016 an increase of four students over last month.

**B. Financial Report**

Assistant Superintendent Temperino reported 98% of the budget has been spent or encumbered to date. The Special Education and Facilities Budgets are being closely monitored; there have recently been several unanticipated expenses impacting both budgets.

Mrs. Temperino provided the Board with a School Tax Rate Analysis for the three towns that makeup the Cooperative School District.

**C. Transportation Ridership Update**

School Bus ridership has averaged about the same as last month.

**D. Elementary Data and Learning Presentation**

Principal Jeremy Hillger, Principal Kathleen Hill, and Assistant Principal Barbara Pope provided an overview of the assessments used to gain a deeper understanding of what students know and need to learn. Both Dynamic Indicator of Basic Early Literacy Skills (DIBELS) and the North West Educational Assessment (NWEA) are used and help determine what supports or interventions may be needed and also project academic growth goals.

By adding an action plan data team, student progress is more closely monitored and data is used to make decisions on how to best assist students with their learning.

Mr. Hillger told the Board it was an exciting time for district educators because as a result of various assessments they no longer wonder where kids are on the learning curve.
