### **INTRODUCTION**

Under the Elementary and Secondary School Emergency Relief II Fund (ESSER II), authorized by the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, the Pennsylvania Department of Education (PDE) awards grants to School Districts and Charter Schools to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the state.

### **Please explain how the LEA will determine its most important educational needs as a result of COVID-19. (3000 characters max)**

Continuity of effective education is of paramount importance to STSD as it functions during COVID-19. Teachers must provide synchronous and asynchronous learning opportunities to engage students, K-12, and maintain daily office hours, Monday-Friday. STSD provides both Synchronous and Asynchronous learning opportunities for its students during COVID-19. Synchronous learning is representative of real-time student-centered instruction during which time students engage with teachers who provide virtual instruction from either their respective classrooms or other designated areas. Asynchronous learning is representative of student-centered instruction during which time students engage with pre-recorded video lessons, assignments, and other learning tasks on their own and instruction is not delivered in person or in real-time. These will be the primary instructional delivery methods for STSD to assist families in managing home/school responsibilities. Office hours are for teachers to assist small groups or individual students, answer questions, and provide additional help. Office hours are communicated to parents via teacher webpages found on the district's website and are available for both Synchronous and Asynchronous student learners.

### **Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)**

Beginning at the onset of the 2020-2021 school year on September 8, 2020, students were provided either in person or virtual instruction using a Microsoft setup that provided virtual students with a classroom like experience from home. In addition, staff provided students with after school virtual tutoring in the evenings and weekends to help prevent gaps from developing in learning. The district is planning to provide a six-week Extended Learning Opportunity for students in June and July 2021 to provide academic assistance for any interested students/families to help close learning gaps that may have developed in the normal 2020-2021 academic school year. To assist with the increasing use of technology, STSD is going to provide staff members with additional training in half hour segments during the spring of 2021 and throughout the 2021-2022 school year.

**Please explain the extent to which the LEA intends to use ESSER II funds to promote remote learning.** (3000 characters max)

STSD has identified how it intends to and already has begun incurring permissible expenditures to provide continuity of effective educational services in response to challenges associated with COVID-19. Specifically, the district will use the ESSER II funds to finance the purchase of student computing devices (IPADS), teacher computing devices, video cameras, and audio equipment necessary to provide on-line virtual instruction to its students. Additionally, STSD will use these funds to finance the applicable portion of wages and benefits for professional staff to both prepare and deliver virtual instruction. Lastly, these funds will be utilized to finance any outsourced services necessary to deliver virtual instruction to district students. The teaching devices will also aid in facilitating the required level of interaction between STSD teachers and administrative staff in support of district educational services.

**Please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services.** (3000 characters max)

STSD purchased the MAP (Measures of Academic Progress) assessment suite from NWEA (Northwest Evaluation Association) in the Spring of 2020. The assessments included in this suite are adaptive in nature so that we can identify where students have areas of strength and weakness in both reading and math. Students will take the assessments within the first week of school. Any areas of weakness can then be reviewed by teachers to determine an instructional path to close gaps resulting from the disruption in education services. STSD has also begun the use of Mass Customized Learning in the 2020-2021 school year. This is being piloted at our Middle School in ELA, math, and related arts. This pilot is being expanded to other buildings in the district in the spring of 2021 and in the 2021-2022 school year. The use of the structure provided by Mass Customized Learning (MCL) will better enable staff to address gaps in student learning in a much more efficient manner. Finally, STSD has purchased a Learning Management System, Empower, which was used during the 2020-2021 school year in our Middle School for tracking the learning and growth of our students in the areas of math and ELA. Empower provides a structure that allows students, parents/guardians, and staff to see at a glance academic progress and gaps in student learning. The use of this Learning Management System will be expanded to other buildings in the spring of 2021 and in the 2021-2022 school year.

**Please describe the LEA(s) proposed procedures for evaluating local COVID-19 impacts in relation to education programming and delivery.** (3000 characters max)

Areas of emphasis should include:

- Documenting learning loss associated with extended school closure;
- Outlining the development of local continuity of education plans over the course of emergency response efforts; and
- Detailing supports for vulnerable student populations and families.

With the MAP assessments (referenced in #4) being given in reading and math to students

within the first week of school in the 20-21 school year, we will be able to capture areas of weakness (or learning loss) as compared to norms from students across the country. These areas of weakness are documented within the MAP assessment platform, and we will also place that information in Empower, our newly purchased LMS (Learning Management System). In this new LMS we will not only be able to review any areas of weakness (or learning loss), but we will also be able to track students' progression in overcoming those areas of weakness (or learning loss). Staff at our Middle School has been inputting student learning data into this LMS in the areas of ELA, math, and related arts throughout the first semester of the 20-21 school year. That will be continued in the second semester of the 20-21 school year and will be expanded to smaller pilots at other buildings to begin to capture and track the student learning data. We will further expand the use of this LMS to all buildings in the 21-22 school year providing training to students, staff, and parents/guardians. This will allow STSD to have a much better picture of student learning, progress, and potential gaps in student learning in order that educational programming and delivery can be adjusted to best meet the needs of students.

**Please describe the LEA core set of strategies that will be used to guide local investment of ESSER II funding, associated with short-range (i.e., remainder of the 2020-21 school year) and long-range (2021-22 and 2022-2023 school years) timelines.** (3000 characters max)

As mentioned in STSD's response to question # 1 and # 2 the district overarching strategy to providing both short and long-term continuity of educational services is and has been to ensure that there is a robust virtual learning platform in place that can be deployed as deemed necessary with respect to COVID-19. Consistent with STSD's Leadership Model an ongoing focus and development of strategic initiatives associated with the district's long-term vision for engaging its students remains of paramount importance. The ESSERS II funding represents financing to continue supporting the district's short and long-term response. Having this funding in place will assist with financing technology, physical infrastructure & furnishings, supplies and labor related expenditures necessary in response to the pandemic. In addition to the anticipated receipt of ESSERS II funding, STSD will continue to consider real estate tax increases, bond refinancing, expenditure reductions and other measures vital to establishing and maintaining sustainable funding levels to finance newly required educational and operational delivery models.

STSD purchased the MAP (Measures of Academic Progress) assessment suite from NWEA (Northwest Evaluation Association) in the Spring of 2020. The assessments included in this suite are adaptive in nature so that we can identify where students have areas of strength and weakness in both reading and math. school. Any areas of weakness can then be reviewed by teachers in order to determine an instructional path to close gaps resulting from the disruption in education services.
