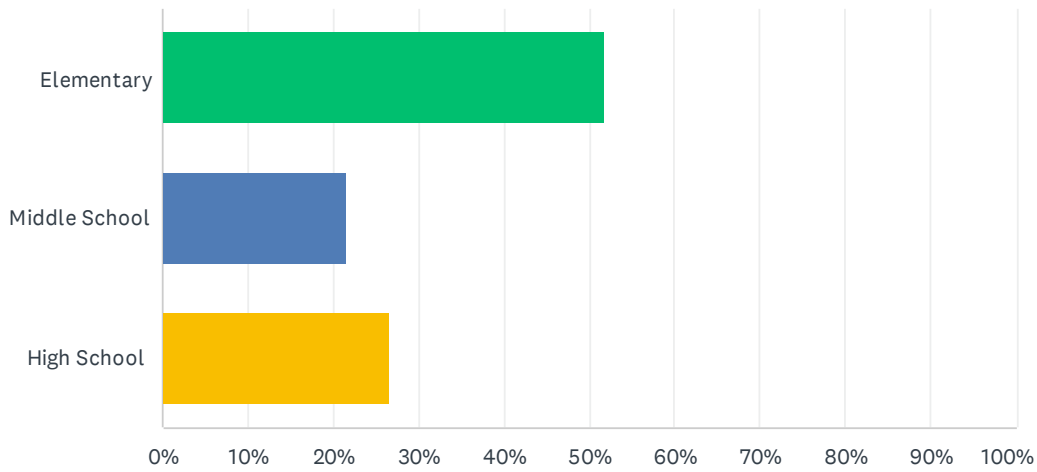


Q1 Child's school level (in the 2021-22 school year)\*Mark only one level.

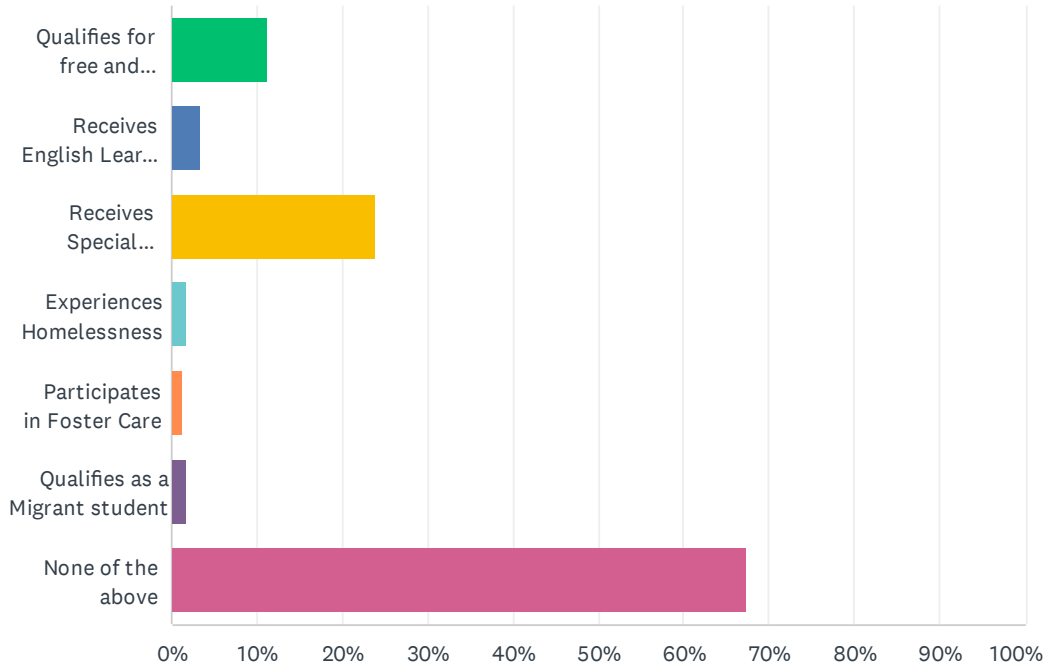

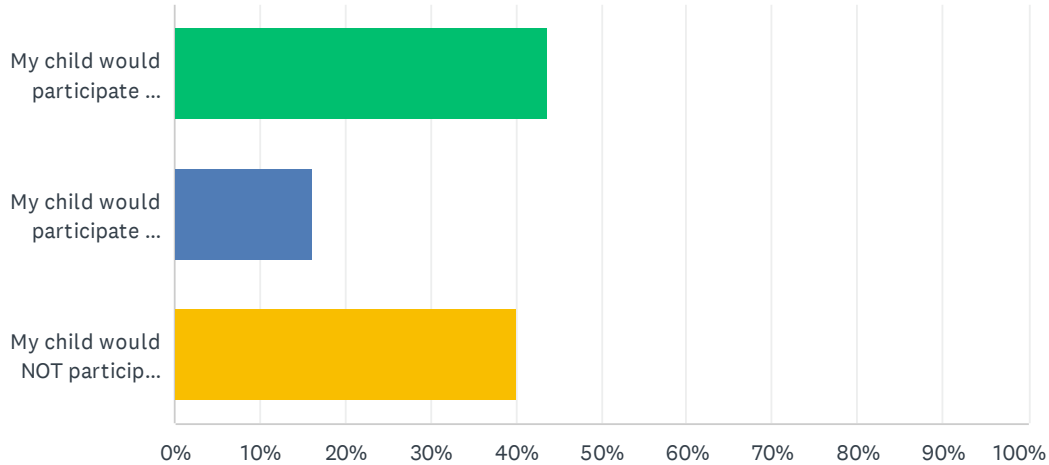

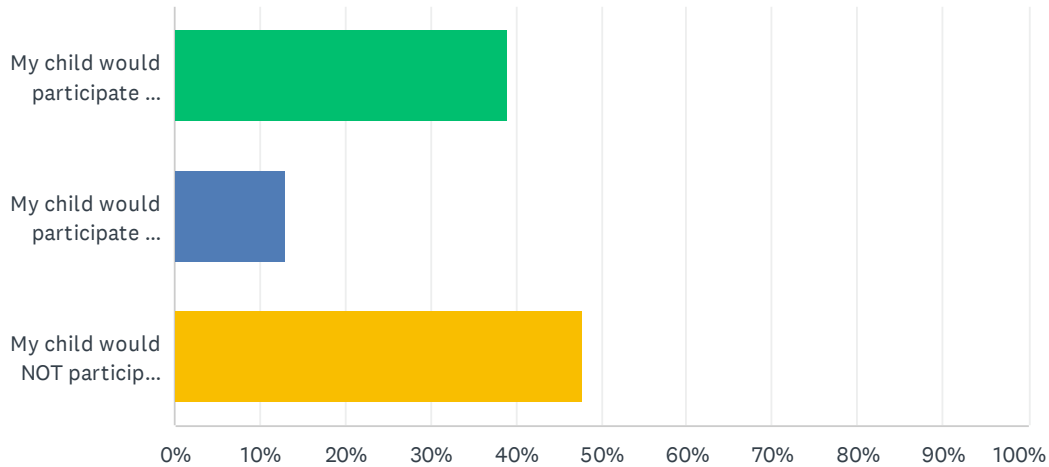

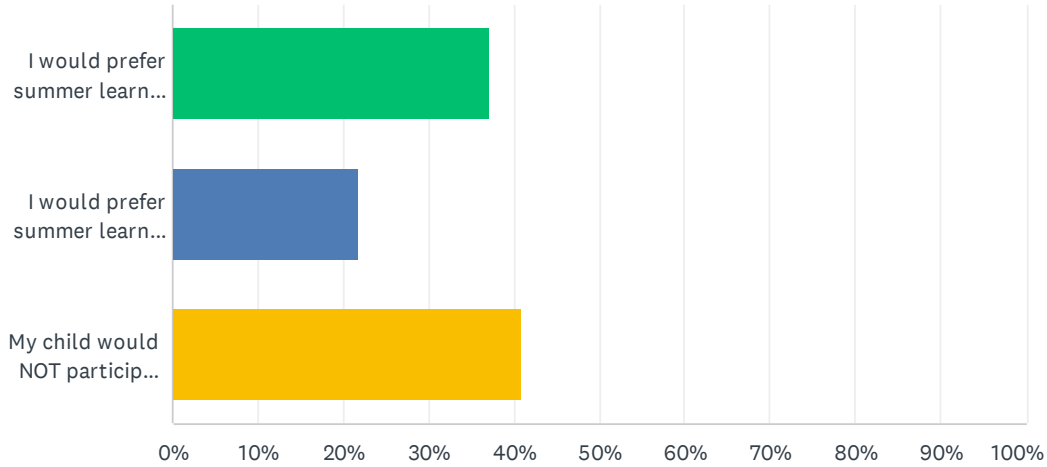

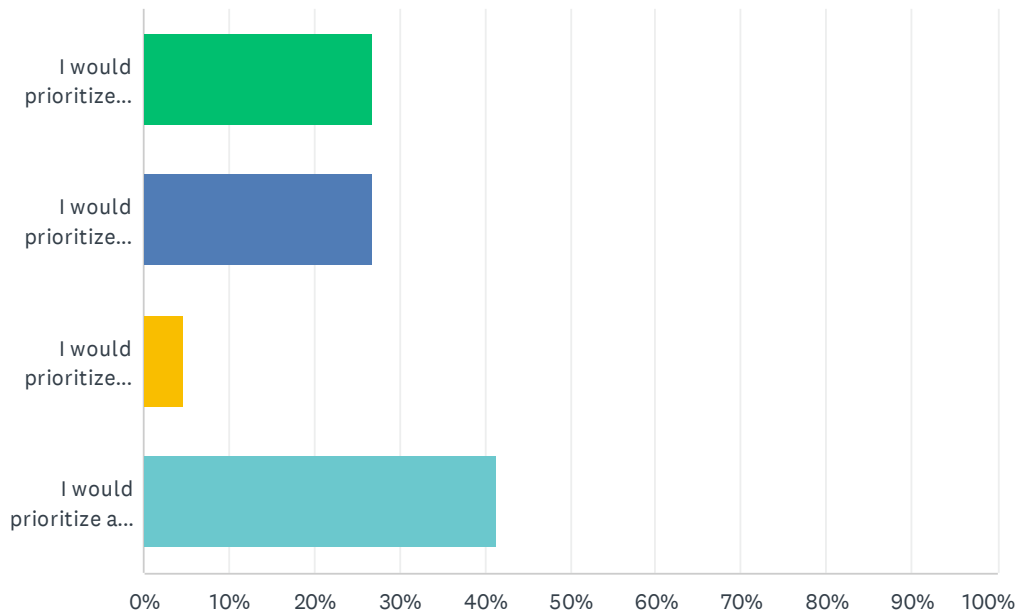
