This is a rigorous, college-level course designed to provide students with the analytic skills and factual knowledge necessary to deal critically with the problems and materials in U.S. history. 

- D. Complete **AP Thinking and/or Writing Historically** activities found at the end of the modules - I have noted pages for each module.

5. Read Period 2, Modules 2-1, 2-2, 2-3, 2-4, 2-5, 2-6 through page 106 and complete all activities in the modules.


In each module, please remember to:
