**Notification of Requirements for 8<sup>th</sup> Grade Promotion Activities**  
**Fantasy Springs Convention Center**  
**June 6th, 2022 at 6pm**

This letter is to inform you of TCMS requirements regarding eligibility criteria for eighth grade promotion and activities. Many students and families look forward to promotion in eighth grade as it is a celebration of successful completion of middle school and a milestone before high school.

The criteria required for full participation in all promotion activities is as follows:

- Good Grades. No failing grades (F) in any class second semester (January-June).
- At TCMS we are Safe, Respectful, and Responsible. No serious infraction of school/district rules, at the Principal's discretion, generally applying, but not limited to any single suspension.
- Good Attendance. No habitual attendance/habitual tardy problems (SART/SARB)

***Students may not participate in the promotion ceremony or activities, unless the above-mentioned criteria are met during the second semester of the 2021-2022 school year.***

At any time during the school year, any eighth grade student that violates school rules or promotion criteria, shall be subject to the following consequences:

1. Exclusion from the activity and referral to the appropriate authority.
2. Suspension or expulsion from school or district, with all due process provided for under California Education Code, Sec. 48900.
3. Exclusion from school activities, which may include but are not limited to:
  - After-school dances
  - ASES program
  - School field trips
  - Promotion ceremony
  - Class field trip
  - Any other activity by administration

In the event of student misconduct, the principal or the principal's designee will immediately attempt to notify the parent(s) or guardian about the nature of the infraction and the consequences. Appropriate disciplinary action shall be taken on the school day immediately following the activity if the incident occurs during non-school hours, such as at a dance or other evening activity. All due process provisions provided for in Education Code Sec. 48900 will be in effect.

Participation in the promotion ceremony and activities is a privilege that we would like all eighth grade students at TCMS to partake in.
