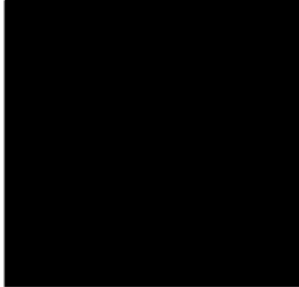

I was already teaching in SC. Chester County upheld the Georgia PSC investigation and I was suspended for 5 days in December of 2016. I had not ever had an accusation or problem before this nor have I had one after this.

I also use technology each week with the students through HUDL, by sharing film of not only games, but practice and lifting sessions in the weight room.
