Good Afternoon,

I hope this email finds you well. I am writing to follow up on our meeting and on the subsequent Board meeting during which the Board discussed the employee grievances filed against Will.

It is my recommendation to the Board that they authorize me to send a letter to each grievant advising that Will now better understands his role as a Board member and that, based on that increased understanding, he will follow protocol when visiting schools and the DO to talk with District employees, including looping the Superintendent in when appropriate.

Will said he wanted to talk with you about my recommendation because he did not want to admit to doing anything wrong. Certainly, I would not phrase the letter to so indicate, but only to bring closure to this matter in the hopes that Will, as well as the employees, can move forward.

Please let me know your thoughts on this matter. The Board is likely to vote on this matter (whether to send the letters) at their upcoming meeting on August 6.
