Hi Tina,

I just called again and was able to get Cliff on the phone. He has spoken with Will about the letters and is fine with that in theory. His concern is that he does not want the letters to reflect that Will has acknowledged engaging in wrongdoing in the event that one or more of the employees files suit against Will and the Board.

I think I can draft the letters without the need to include an admission by Will—I will be drafting those tomorrow or Friday—I told Cliff I would send him a copy.

As we discussed, I don't want to copy the Trustees so we don't get into a situation where they could be subject to disclosure under FOIA. I would like, however, for you to see the copies before the meeting on August 6. I will send you the drafts for your review and input.
