I think this sends a positive message to the grievants as far as the Board's response to the grievances. The employees will receive my letters stating those conclusions and recommendations and know that the Board endorses those.

The downside is that Trustees may be asked for the nature of those "conclusions and recommendations."

Since that information is attorney-client privileged, no Trustee is obligated to answer such questions. Further, if a Trustee wished to share that information, the privilege belongs to the entire Board and not to an individual Trustee, meaning that a majority of the Board would have to vote to waive that privilege.
