Hi, Frida:

In response to your FOIA requests submitted on Feb. 4, 5, and 7, please see the attached copies of the current Crime Policy, General/School Leaders Liability Policy, General Liability Certificate of Insurance, Sworn Oath for newly elected BOE members, and ESSER information.

Title 8, Chapter 3, of the South Carolina Code of Laws, including Section 210 of Chapter 3, is applicable to officers and employees of the State government and its boards, bureaus, departments, commissions, and other instrumentalities, but is not applicable to school district officers or employees like district superintendents. Therefore, that Chapter and section of the law do not require

that our District's officers or employees be bonded or that we have or maintain the related items of your request.

The Beaufort County School District (BCSD) is a member of the South Carolina School Boards Insurance Trust (SCSBIT). SCSBIT provides manuscript (i.e. custom) policies in South Carolina tailored to the unique needs of school districts. SCSBIT typically does not use forms from The Association for Cooperative Operations Research and Development (ACORD) in their policies because they are generic standardized forms.

I am a private citizen seeking information concerning your public official surety bond that you are required by

the state of South Carolina to obtain before swearing the oath of office.

Public Official Surety Bond requests fall under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, The Sunshine Act 5 U.S.C. § 552b, S.C. Code Ann. §30-4-10 to 30-4-55, and by law you are obligated to supply me with this information.

SC Code § 8-11-20: All persons who hold or are appointed to any of the positions in the departments of the State government referred to in this section, or who shall be appointed by any of such departments as accountants to investigate and report the condition of any State or county officer, shall take oath of office in the usual form and the constitutional oath and give good and sufficient bond in the form of official bonds as prescribed by Section 8-3-30. Such bonds shall be approved and filed as the bonds of other State officers. In the instance of individual bonds to be given pursuant to this section by employees of each of the departments referred to below, the penal sums of such bonds shall be as follows: For each clerk in the office of the Secretary of State, four thousand dollars; for each clerk in the office of the Comptroller General, five thousand dollars; for each clerk in the office of the State Treasurer, ten thousand dollars; for each clerk in the office of the State Superintendent of Education, twenty-five hundred dollars; for each stenographer or typist in the office of the State Treasurer, twenty-five hundred dollars; for each Assistant Attorney General, twenty-five hundred dollars; and for each accountant appointed by any of such departments, five thousand dollars.

Please supply me with a photocopy of the documents I have requested within the next (72) hours. Under the FOIA Act for the State of South Carolina you are required to supply anyone a copy of this information if requested.
