## FACTS FAQ Answers to common questions

## Q. Is my information secure?

**A.** Yes. Your personal information, including payment information, is protected with the highest security standards in the industry. For more information on security, visit FACTSmgt.com/Security-Compliance.

### Q. What happens if a payment is returned?

**A.** Returned payments may be subject to a FACTS returned payment fee. Watch for a returned payment notice for additional information.

# Q. How do I make changes once my agreement is on the FACTS system?

**A.** Changes to your address, phone number, email address, or banking information can be made at Online.FACTSmgt.com or by contacting your school or FACTS. Any changes to payment dates or amounts need to be approved by the school and the school will then need to notify FACTS. All changes must be received by FACTS at least two business days prior to the automatic payment date in order to affect the upcoming payment.

## Q. Do I need to set up an account if I pay in full?

**A.** Yes, select the annual payment option and your desired payment method.

# Q. Will I be able to see my balance and payment schedule before submitting my FACTS tuition account?

A. No, after you submit your tuition account, the school will apply all applicable discounts and aid to your FACTS account. Once this has been done they will "activate" the account and you will receive a detailed statement of your balance and payment schedule. Please check this information for accuracy and contact the school or FACTS with any discrepancies.
