- 6-8 Middle School in the Poly
  Planning Area
- Site Located at E. 20<sup>th</sup> Street/Cherry Avenue (8+ acres)
   – Former GTE Site
- 800 Students (840 capacity)
- 31 Classrooms (89,288 square feet)
- Library/Media Center, Gymnasium, Multipurpose Room, Other Support Facilities including a Soccer Field and Hard Court Areas
- Total Project Cost \$ 54.4M
- Expended to Date \$ 20.9M




- Construction Budget: GMP \$38.3M






