**WHEREAS**, two or more educational facilities have collectively formed a joint insurance fund as is authorized and described in N.J.S.A. 18A:18B-1 *et. seq.* and the regulations promulgated pursuant thereto; and

WHEREAS, the Educational Facility is currently a member of said

Fund; and WHEREAS, the Educational Facility has resolved to renew said membership;

# NOW, THEREFORE, it is agreed as follows:

- 1. The **Educational Facility** hereby renews its membership in the **Fund** for a three (3) year period, beginning July 1, 2016, and ending July 1, 2019 at 12:01 a.m. eastern standard time.
- 2. The **Educational Facility** agrees to participate in the **Fund** with respect to the types of insurance stated in the Renewal of Membership Resolution.
- 3. The **Educational Facility** hereby ratifies and reaffirms the bylaws and other organizational and operational documents of the **Fund** and as from time to time amended by the **Fund** and/or Department of Banking and Insurance in accordance with the applicable statutes and regulations as if each and every one of said documents were re- executed contemporaneously herewith.
- 4. The **Educational Facility** agrees to be a participating member of the **Fund** for the period herein provided for and to comply with all of the rules and regulations and obligations associated with said membership.
- In consideration of renewal of membership in the Fund, the Educational Facility agrees that for those types of insurance in which it participates, the Educational Facility shall jointly and severally assume and discharge the liability of each and every member of the Fund all of whom, as a condition of membership in the Fund, shall execute a verbatim counterpart to this Agreement. By execution hereof the full faith and credit of the Educational Facility is pledged to the punctual payment of any sums which shall become due to the Fund in accordance with the bylaws thereof, this Agreement or any applicable statute or regulation.
- 6. If the **Fund**, in the enforcement of any part of this Agreement, shall incur necessary expense or become obligated to pay attorney's fees and/or court costs, the **Educational Facility** agrees to reimburse the **Fund** for all such reasonable expenses, fees and costs on demand.
- 7. The **Educational Facility** and the **Fund** agree that the **Fund** shall hold all monies paid by the **Educational Facility** to the **Fund** as fiduciaries for the benefit of **Fund** claimants all in accordance with applicable statutes and/or regulations.
- 8. The **Fund** shall establish and maintain Trust Accounts in accordance with N.J.S.A. 18A:18B-1 *et. seq.* and such other statutes and regulations as may be applicable.
- 9. The Business Official designated in the Resolution to Renew Membership is hereby authorized to execute the Agreement to renew membership.

In accordance with N.J.A.C. 6A:7, Managing for Equality and Equity in Education, the CEP Committee conducted a district-wide needs assessment and developed a three-year Comprehensive Equity Plan. This document will be presented to the NJDOE, Bergen County Office of the Executive Superintendent for approval on/or before April 1, 2016. The plan provides citations of documentation and evidence to substantiate compliance with the many state requirements regarding policies, programs, practices and conditions which may be inequitable.

This evening the Lyndhurst Board of Education will approve the submission of the CEP by resolution of the Statement of Assurance affirming compliance with laws, statutes and regulations governing equity in education.

Congratulations to the Affirmative Action Officers and members of the CEP Committee

- On Monday evening, March 14<sup>th</sup>, the Lyndhurst Public Schools proudly sponsored a special event called "NJ Scores!" This presentation, funded by We Raise New Jersey, the NJ Chamber of Commerce, and the NJPTA focused on the PARCC assessment and its connectivity to the preparation of students for college and career. Only 30 presentations were made available statewide and our district was honored to have been selected. During this "NJ Scores!" presentation, parents/caregivers:
  - engaged in short activities to help them understand the shifts in teaching and learning that the new assessments will produce,
  - o reviewed surprising data about college remediation and graduation rates, and
  - learned about the hidden benefits that are attached to successful performance in the state assessment.

The presenter, Mrs. Dara Egreczky reviewed the changing nature of the workplace, discussed the latest research on how children become the critical thinkers that business will need, and

detailed the growing use of tests by employers in multiple fields, as well as for the military and for college placement purposes.

Township of Lyndhurst was greatly affected by the events of September 11, 2001, due to its proximity to New York City and impact of friends, family and community members who perished. In solemn memory of this tragedy, the Lyndhurst High School Student Government, under the leadership of Principal Laura Vuono, would like to commemorate the upcoming 15<sup>th</sup> anniversary.

The plan is to do this through "LYNDHURST WAVES", an art installation of 2,977 flags representing each individual we lost that day.

"LYNDHURST WAVES" was inspired by a similar display at Pepperdine University in California. Lyndhurst High School students will be involved in the installation, maintenance and removal of the project. The LHS Student Government is raising the necessary funds and coordinating this comprehensive initiative. We believe this will be an impactful lesson to our students, many of which were only infants at the time of this event in history.

- Ms. Luann Voza, District Supervisor of Mathematics, recently announced that students in grades 5-8 participated in the Math Con Competition. This competition is an online program that consisted of the completion of 40 items by grade level. After the first round, students selected as finalists may move on to the final round, which is held in Chicago later this spring. One fifth-grade student in Roosevelt School, Ken Chen achieved a perfect score of 300. Ms. Voza registered him for the grade 6 test and he received a score of 276 (out of 300) and Grade 8 students, Lennon Okun scored 290 and Joseph Park scored 280.
