## THE POLICY

The Salt Lake City School District Board of Education implements curriculum and instruction standards, competency measures, dropout and recovery services, and high school graduation requirements in accordance with Utah's laws and administrative rules.

The purpose of this policy is to ensure the district clearly and consistently communicates applicable standards, measures, and requirements to its stakeholders, and offers appropriate guidance and support so that every student has the opportunity to earn a high school diploma.

The district allows interested students who have met all graduation criteria the option to graduate early. Additionally, the board may, in certain circumstances, award an honorary high school diploma to a veteran if the veteran left high school before graduating in order to serve in the armed forces of the United States.

The district recognizes that a student's graduation is a culmination of years of planning and successful completion of many requirements. Only students who have completed all graduation requirements and are in good standing will be permitted to participate in high school graduation ceremonies. Participation in the graduation ceremony is a privilege, not a protected right.

The district has set forth its specific processes for implementing this board policy through the accompanying [administrative procedures](#).

No district employee or student shall be subjected to discrimination in employment or any district program or activity on the basis of age, color, disability, gender, gender identity, genetic information, national origin, pregnancy, race, religion, sex, sexual orientation, or veteran status.
