Little Canada Elementary School 2021-2022 Parent and Family Engagement Plan

Little Canada Elementary School is committed to the goal of providing quality education for every child in this school. We want to establish partnerships with parents and with the community. Everyone gains if school and homework together to support high achievement of our children. We can't do this job alone. Parents and families play an extremely important role as children's first teachers. Their support for their children and for the school is critical to their children's success at every step along the way.

Part I. Description of how the District and School will Implement Required Components

1. Little Canada Elementary School will engage parents and families who have Title I students in developing/revising the district and school Plan.

Little Canada leadership team met during the week of August 9th to review the previous year's School Improvement and Parent and Family Engagement plan, completed a comprehensive needs assessment and created a draft of the 2022 SIP and PFEP. The school teams consulting on the creation of the plans consisted of 10 staff members. The Parent and Family Engagement plan was informed by the BIPOC and School Community Listening Sessions in the spring and 4 Little Canada parents in PTA Leadership aided in its development. . The plan was created in collaboration and with feedback from the Little Canada Parent Teacher Association Administrative Board and parents.

2. Little Canada Elementary School will convene an annual meeting, at a convenient time, when the parents of participating children are available to attend. The Title I annual meeting will inform parents about the Title I program, explain the requirements of parent and family engagement and the rights and responsibilities of the parents to be involved.

Representatives of the Little Canada Elementary School improvement team will present a draft of the School Improvement Plan and Parent and Family Engagement Plan to the Little Canada community at the September PTA meeting on September 16th. We will discuss goals and seek feedback from the larger community to ensure that the plan meets the needs of our community as a whole. Teachers will review the Title I Parent/Student/Teacher Compact at fall conferences at the end of September. The plan will also be published on our school webpage and available for all families. Hard copies will be mailed home upon request.

4. Little Canada Elementary School will offer flexible meeting times during morning, evening or weekends and may provide transportation, childcare, or home visits.
5. Little Canada Elementary School offers morning and evening conferences for families at least twice a year and in the past has conducted home visits for families that are interested. We will continue to monitor COVID health protocols to ensure that we are meeting all safety requirements, but it is our plan to offer both in person and online options for families whenever possible. Parent teacher conferences, PTA meetings and all other "school gatherings" will be conducted following strict in person health

guidelines, through Zoom or by YouTube presentations. Little Canada Staff is committed to connecting with families through Zoom, Google, Schoology, Seesaw and by phone at flexible times throughout the day based on parent needs. Little Canada will continue to provide transportation and interpreters as needed. The Parent and Family Engagement Plan will be reviewed throughout the year and adjusted as needed based on health and safety standards and family and community feedback.

6. Little Canada Elementary School will involve parents in the planning and review of the School Engagement Plan and the joint development of the schoolwide plan when applicable. Little Canada Parents on the PTA Executive Council helped create the Family and Parent Engagement Plan and the larger school community was involved through multiple listening sessions in the Spring. We will continue to work with PTA leadership in consultation and evaluation. Parent feedback includes general satisfaction with historical events like Little Canada Open House/Academic Fair showcasing academic work and activities students are involved in, Back to School Night, Curriculum Night, Pumpkin Carnival, Ice Cream for Books events, technology night, and the Little Canada Talent Show. Feedback was positive from parents for communication tools like the use of SeeSaw and Schoology, parent/ teacher conferences and increased communication last year’s many transitions. Parents were very appreciative of staff outreach efforts like staff videos and events such as drive through graduation and Car Parade. Parents have expressed an interest in increasing communication opportunities by developing a school wide phone directory, increasing in person social events, and finding ways to creatively (and safely) reconnect after 2 hard years. Little Canada PTA leadership is interested in working jointly to increase culturally and/or linguistically specific community events including the possibility of creating a World Cultures Night in the spring.

7. Little Canada Elementary School will provide assistance to parents of Title students:
 - a. Timely information about programs offered to engage in their child’s education.
 - b. An explanation of the curriculum, state and local academic assessments including alternate assessments, and the achievement levels of the state academic standards.
 - c. If they request, opportunities for regular meetings to hear their suggestions and participate in decisions related to their child’s education.
