Dear Parents / Guardians,

As parents of kindergarteners, we know that there is a great deal of excitement you feel when your student enters school. We share your excitement and are busy preparing to ensure the student(s) are met with a smooth and easy transition. To contribute to these efforts, the Transportation Office needs your assistance.

Parents / guardians of all kindergarten students who will be riding a bus are required to read this form and identify dismissal choice. Please consider the options presented and select the **one** most suitable for your student(s). Upon determination please complete the form below (one form per student) and return it to your assigned professional bus driver as soon as possible.

To support the safety of all students, it is critical that we have this information. **Please know that bus drivers cannot drop your student(s) off at the bus stop without a designated representative meeting him/her at the bus stop. Your student(s) will be returned to the school and you will have to pick him/her up there.**

Your student's dismissal information, specifying your preference and understanding of procedures, will be kept on file with the professional bus driver and our Transportation Office.

This is for the safety of your student(s)! We will also put on your student's backpack in a conspicuous position a label tag which will help identify your student as a kindergartener. This will assist our personnel in recognizing your student(s) as needing to be met at the stop. If you cannot make it to pick up your student(s) please call the school and transportation.
