TUSD used LCAP survey data from students, staff, and parents to develop the plan. In addition, a second survey was administered to all parents, classified, and certificated staff to collect feedback regarding academic and mental health services for students, and staff training. The district also provided grant overview information and opportunities to provide input from school leaders, parents at Title 1 Parent Advisory Committee meetings, as well as consult meetings with Certificated and Classified Bargaining teams to develop the input survey, review feedback, and see where it was implemented in the plan. Spring 2022, the Elo Grant expenditure window was extended from September 30, 2022, to September 30, 2024. The spring 2022 District LCAP survey administered to students, staff, and parents was used to collect input for the grant expenditures.

A description of how students will be identified and the needs of students will be assessed.

TUSD will identify students focusing on students that did not attend kinder in the 2021-21 school year, English Learners, Homeless, Foster, credit deficient students, students with disabilities, and students at risk academically/social emotionally. The data to identify the needs will include students who referred to Student Services for attendance re-engagement, grade reporting, and the skills assessment diagnostics in ELA, Math, and Social Emotional needs. For the 2020-21 school year the diagnostics were administered at the end of the first and second semester. Throughout the 2021-24 school year, TUSD will use the Fastbridge skills-based diagnostic to measure a baseline and measure progress for all students 3 times a year (beginning, middle, and end of year) and in 6 to 8-week intervals for students receiving Tier 2 interventions. For re-engagement and credit deficient students, the district will utilize attendance reports and Edgenuity credit recovery student progress reports.

TUSD will use the Multi-Tiered System of Supports Framework (MTSS) to share the available Tier 1, 2, and 3 menu of supports, interventions and resources available to students, based on their need. This will be provided in a published document format, shared online, and with email/voice mail options. All communication will be provided in both English and Spanish.

A description of the LEA's plan to provide supplemental instruction and support.

TUSD plans to provide Tier 2 intervention both during the day and after school in ELA, Mathematics, and Social Emotional Learning. This will include intervention supports provided by teachers and paraprofessionals to support literacy and math skills. Mental Health Tier 2 and 3 counseling services for students will be available at all schools in the district, 5 days a week, provided by mental health counselors. Tier 1 counseling services will be provided by school counselors.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The Extended Learning Opportunity Grant Funds were coordinated with ESSER grant funds in planning and development. The ELO funds will pay for year 1 of services and the ESSER grant funds will fund year 2 and 3 of services. Upon the 3rd year (2023-24), TUSD will evaluate the impact of ELO and ESSER services and prioritize sustainable action services reflected within the LCAP.

Spring of 2022, the ELO Grant expenditure window was extended to September 30, 2024. The revised plan expenditures are reflected above.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

• "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, EC Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in
 distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional
 services are offered.
