

November 8, 2016 Edison Elementary School – Measure I Bond Project

Site Committee Meeting #3 Notes

Notes:

- 1. Jen Howl stressed thermal comfort as the top priority. QKA walked her through the strategies incorporated into the design.
- 2. Jen also expressed her concern about the community being involved with the fencing process. She mentioned this is not a concern if Proposition B passes.
- 3. New Principal (Rob) was already briefed on the design scope by Robbie Lyng. He asked if the design was on Budget. NS indicated that grayed out priorities (slide 3 in today's presentation) are not funded and not currently included, black items on the slide are included within the budget.
- 4. Fencing will be coordinated with modernization project (this project).
- 5. Principal Slauson asked about the operation of window and blinds. NS and BP explained the idea of having a hopper type window that opens into the classroom for increased security in the event that windows are accidentally left open overnight. The hopper windows will need to be closed if blinds are drawn down to the sill.
- 6. Since the window opening is fairly high, BP expressed that perhaps the lower (middle) window should be operable and directed us to proceed with that approach.
- 7. Principal Slauson requested interior windows with shades in the Principal's Office and Nurse Room. QKA confirmed that interior glazing was not shown in the drawings, but it was indicated in the Schematic Design specification narrative to be included in the budget.
- 8. Principal Slauson would like to incorporate the Conference Room into his office to accommodate large meetings of 6 to 8 people and use the left over space as Storage or a small Itinerant Office.
- 9. When discussing the temporary housing during construction, it was suggested to start by remodeling the existing Media Center during the summer, move the Administration staff over upon completion, and then work on the new Media Center during the fall. An empty classroom space will be designated as the Media Center in the interim.
- 10. The perimeter fencing installation should start in about 6 weeks.

- 11. Discussed the potential to add operable windows to existing transom windows above doors at classrooms. QKA to investigate if this is feasible in the budget.
- 12. Principal Slauson discussed the potential of relocating the Kindergarten classroom to the Pearl Street wing and installing a play area between the outdoor corridor and the new fence line. Tree roots could be problem. NS indicated that tree removal and new surfacing is not in the current project or budget and would need to be a future project if funds are available.
- 13. Budget: Project design as present falls within the current budget as established for Edison in the Board approved Implementation Plan B.
- 14. Schedule: QKA presented the following tentative schedule. Times may shift based on the decision making process and approvals.
 - a. Board Approval: December 13, 2016
 - b. Design Development and Construction Documents: roughly December 2016 June 2017
 - c. Agency Approval and Bidding: roughly June 2017 February 2018
 - d. Construction target to begin: Summer 2018
- 15. While walking the campus, the existing blinds appeared to be in good condition since they were replaced in the previous Bond. QKA was directed to reinstall the existing blinds rather than providing new Mechoshades.
- 16. Next Steps:
 - a. Make minor adjustments to the Administration layout as discussed above.
 - b. Prepare Board presentation and send draft to Brenda 1 minimum week prior to board meeting.
 - c. Present Schematic Design to Board for approval.



Campus Plan | Thermal Comfort




Existing Conditions | Thermal Comfort








Campus Plan | Existing Conditions

Existing Administration and Media Center I Floor Plans







