#### Call to Order

The meeting was called to order at 7:45 a.m. by Chair Willett. Following the Roll Call and the Pledge of Allegiance, Willett welcomed the group, explained the purpose of the meeting, and procedures to be followed.

#### **Public Participation on Non-Agenda Items**

None

#### Future of SAFE-TI Services – Discussion and Reports

Superintendent Watson introduced the item. SAFE-TI services are currently funded by a grant that expires at the end of the school year. The District proposed a legislative change that would create a levy mechanism for funding the operational costs of school safety. That proposal was forwarded to MTSBA, and the MSTBA membership recently approved a version of that proposal. At MTSBA's direction, a bill to include those costs

in the Building Reserve Fund is being drafted. The bill draft will be consistent with the terms of the MTSBA resolution as well as the findings of an interim legislative committee that also studied the issue.

A discussion of the proposed funding structure ensued. Trustees generally felt the initiative was important, but several Trustees voiced concerns about the lack of transparency that the Building Reserve structure would cause.

Deputy Superintendent Instruction Marilyn King and Director of Special Education Chad Berg then reviewed the SAFE-TI and Multi-Tiered Systems of Support (MTSS) programs, and the staffing structures that currently support these programs.

#### Grade Level Reading Initiative – Discussion and Reports

Superintendent Watson introduced the Grade Level Reading Initiative discussion. The United Way will launch Dolly Parton's Imagination Library on November 16, 2018, a concept that was initially introduced by the District earlier this summer. The initiative is a joint venture between the United Way, Bozeman School District, Bozeman Noon Rotary, and others.

Dr. Watson then showed data regarding summer learning loss. To address the issue, Watson intends to challenge all Bozeman School District students in grades K-2 to read at least 100 books next summer. The plan involves opening three of the District's elementary libraries three days a week so students can access the resources available there.

#### <u>District Structure – Discussion and Reports</u>

Superintendent Watson distributed the District's central office organizational chart. A concern exists regarding the number of direct reports for each Deputy Superintendent. Other models exist and Watson distributed an example of a flatter structure. It was noted that there is no perfect solution and that the model may need to evolve over time.

The Board encouraged Administration to continue the discussion and ensure adequate supports are in place to accomplish the District's goals.

The Trustees acknowledged the Grease musical production culminating this weekend. Trustee Fischer noted that he will be meeting with Sunrise Rotary to discuss homeless initiatives. Trustee Reinhardt noted the upcoming Veteran's Day. Trustee Lusin requested a meeting be scheduled with area legislators.

- 2. Bid Package #2 was approved by the Board of Trustees on April 23, 2018 for a sum of \$27,281,392.
- 3. Bid Package #3 was approved by the Board of Trustees on June 20, 2018 for a sum of \$37,178,972, which provided for a total Guaranteed Maximum Price (GMP) contract amount of \$78,711,680.

# **Project:** BHS Site Work (Internal circulation, parking, roundabout and activity fields) Schedule:

- 1. June 28, 2018 The Board of Trustees approved Early Work Amendment #1 and rejected Bid Package #1.
- 2. August 20, 2018 City of Bozeman Exemption Hearing was held.
- 3. The Board approved the pre-selection of a site work contractor on September 10, 2018.
- 4. Bids for Phase 1 of the project were publicly opened on September 18, 2018.
- 5. The Phase 1 Base Bid was approved by the board of trustees on September 28, 2018.
- 6. City of Bozeman Planning approval was received on September 25, 2018, with the required building permit still pending.
- 7. The Board approved the Guaranteed maximum price of \$9,088,367 on September 28, 2018.
- 8. A pre-construction kick-off meeting was held on site October 2, 2018.

#### Progress Update

- o The following items need to be addressed with the City:
  - Right-of-way acquisition Complete
  - The (Special Improvements Lighting District) SILD paperwork has been submitted to the City. Verbal permission was received from NWE to remove lights along Cottonwood Road in the existing SILD. The City will generate an intent to create the SILD in January and the SILD should be created in February.

#### o Permits

- Concession Building TS and BF met with Chris Saunders to discuss impact fees on October 3, 2018. The impact fees will be reduced once the planning Modification has been forwarded to Chris to reflect the single 2" water meter. A Planning Modification to the original submittal is required.
- Planning Modification was issued to include four exempt wells and reduce domestic water meter size. A letter approving the well locations from DNRC is required. DNRC requested a minor modification to the plan. The revised plan was issued and approval granted. Responses to the Cob comments will be issued this week.



#### **OBSERVATIONS**

Nathan Helfrich (CTA) made a bi-weekly site visit to observe general construction progress. The following items were observed:

#### Work in progress:

- 1. Insalling densglass sheathing at the south wall of region A.
- 2. Plumbing rough-in at the restrooms and locker rooms between the auditorium and competiton gym.
- 3. Installing roof josts at region F.
- 4. Exterior wall framing at the north wall of region C
- 5. CMU at the north and east walls of the auto shop
- 6. Roofing at the competition gym
- 7. Installing stair guardrails
- 8. Installing rain leaders at the competition gym
- 9. Preparing elevated decks for slab pours at regions A, B, and C
- 10. Fireproofing at regions A and C

#### General Observations:

- 1. Steel installation is complete at regions A, B, C, and D. Approximately 70% of the steel installation in region F is complete.
- 2. The east and north CMU walls of the auto shop are near completion
- 3. The competiton gym roof installation is approximately 60% complete.
- 4. The region B and D steel stair structure has been installed. The guardrail is not yet installed.
- 5. The guardrails have been installed at the library stair. The guardrail at the east side of the library sair is not alogned properly and will need to be removed and re-installed. Nathan Helfrich discussed resolution with Kevin McCoy and Josh Henigman.
- 6. Exterior framed walls are installed at the perimeter of regions A and C, with the exception of the east wall of region C. The exterior framing is aligned with the face of the stemwall, rather than the face of the densglass sheathing being aligned. This creates a gap between the slab and the inside face of framing at the upper floors that might exceed the maximum that would be concealed by the gypsum board and rubber base. Nathan Helfrich and Bob Franzen discussed the condition with Josh Henigman. Langlas and Associates will review the condition on site to see if the framing can be adjusted to limit the gap, since there won't be flooring in lot of locations where this condition occurs.
- 7. The region C second floor slab has been poured.
- 8. Metal decking has been installed at the region B second and third floors.
- 9. The southwest parking lot has been paved and striped. The drive from Cottonwood Road to the parking lot has also been paved.
- 10. A portion of Cottonwood Road has been paved, north of Annie Street.

- 1. Sidewalk prep and pour next week and the week after
- 2. Structural fill at the track and field building next week
- 3. Comfort station utilities next week

#### **OBSERVATIONS**

Nathan Helfrich (CTA) and Bob Franzen (CTA) made a bi-weekly site visit to observe general construction progress. The following items were observed:

#### Work in progress:

- 1. Insalling CMU at the north and south walls of the weight room.
- 2. Bead blasting the precast panels at the west wall of the south auxiliary gym. The south wall is complete and the east wall is complete except for one panel at the temporary stair location.
- 3. CMU installation at the grid 4 shear wall in region E.
- 4. Installing roofing at the competition gym. The roofing installation is approximately 70% complete at the gym.
- 5. Installing trench drains at the kitchen.
- 6. Spray applied fire proofing installation is underway at the west end of the region A first floor.
- 7. Wall sheathing is underway at region A.
- 8. Metal floor deck installatin is underway at region D.
- 9. Installing slab protection at the region A third floor.
- 10. Metal deck installation is underway at the region A roof.
- 11. Gas line installation is underway north of the competition gym.
- 12. Electrical rough-in is underway at the auxiliary gyms.
- 13. Plumbing at the region C first floor.

#### General Observations:

- 1. Gravel has been installed at the competition gym, except for the area at the north bleachers.
- 2. The exterior CMU at the metal shop where the welding booths will be located is stacked 6 courses high, but doesn't have the electrical rough in for the welding booths.
- 3. The slabs have been poured at the region A and B third floor.
- 4. Top track framing for interior walls has begun at region A
- 5. The library stair guardrail alignment has yet to be addressed.
- 6. The south railing at the region D second floor opening needs to be straightened at the east end as it appears to be bowed.
- 7. The spray applied fireproofing is not adhering to the bottom and sides of structure at all locations.

#### Upcoming work (next two weeks:)

- 1. Excavate the northeast pond next week
- 2. Strip topsoil and cut in Oak Street next week and the week after
- 3. Move fill material to Oak Street and the roundabout the week after next
- 4. Strip top soil and shape the track next week and the week after
- 5. Geothermal extration well work next week and the week after

- 6. Install pens and sleeves at region G2 slab next week
- 7. Install CMU at exterior walls in region E next week and the week after
- 8. Joist and deck installation at regions D and F next week and the week after
- 9. Install roof deck at regions A, B, C, and D next week and the week after
- 10. Install structural steel at region G the week after next
- 11. Install roof drains at regions A, B, and C the week after next
- 12. Frame parapets at regions A, B, and C next week and the week after
- 13. Install spray applied fireproofing next week and the week after

#### Discussions:

- 1. Nathan Helfrich and Bob Franzen discussed the status of the library stair guardrail with Josh Henigman. Josh stated that the subcontractor had not gotten back to it yet to fix it.
- 2. Nathan Helfrich and Bob Franzen discussed the bowed region D railing at the south side of the floor opening with Josh Henigman.
- 3. Nathan Helfrich and Bob Franzen discussed resolution for the location of the face of exterior framing with respect to the face of the stem wall with Josh Henigman. Josh stated the possibility that the 5/8" gypsum board would extend down the wall past the slab so backer rod and sealant could be installed to prevent the baseboard from getting pushed into the void. It was not clear whether or not this solution would work, since the gap would still likely exceed the depth of the gypsum board and baseboard combined. More investigation is required to determine final resolution.
- 4. Nathan Helfrich and Bob Franzen discussed the fire proofing not adhering to structure during the owner/architect, contractor meeting. Langlas and Associates stated that the fireproofing requires a second pass to address areas that didn't accomplish full coverage.

#### ISSUE:

Approval of new course names and course description revisions for Bozeman High School.

#### FACTS:

- 1. The most significant changes are found in the Social Studies Department, which is proposing adding a new course entitled AP World History. In addition, all course descriptions are proposed to be updated to reflect C3 standards. The C3 Framework, like the Common Core State Standards, emphasizes the acquisition and application of knowledge to prepare students for college, career, and civic life.
- 2. There are some minor changes proposed by departments and approved by the Bozeman High School and Central Office administration:

#### INSTRUCTION

#### Curriculum Development

The District recognizes its responsibility for the improvement and growth of the educational program of the schools. To this end, the curriculum shall be developed on a continuing basis and in accordance with a plan for curriculum development adoption, implementation and evaluation.

District-wide curriculum activities shall have the following goals:

To review existing district standards and benchmarks

To establish standards and benchmarks based on research and best practice

To determine a logical scope and sequence for K-12 instruction

To articulate K-12 programs

To identify program omissions and duplications

To assess the extent to which a program does what it purports to do

To determine the extent that a program meets the needs of students

To identify changes and trends in the school community

To provide a database for decision-making and long-range planning

To inform the community of program quality and effectiveness

To guide professional development

To provide guidance for the selection of instructional materials based on research and best practice

To identify areas where curriculum content can be integrated

The development and implementation of the curriculum is the joint responsibility of the District's professional staff. The Curriculum Director, under the direction of the Deputy Superintendent Instruction, has the primary responsibility for the orchestration and coordination of all curriculum development activities. The building principals are responsible to supervise the implementation of the adopted curriculum and materials. The teaching staff has the primary responsibility for the implementation of curriculum as well as an important responsibility in its development.

Proposals for new courses may come from professional staff, parents, patrons of the district, or other interested persons. Any proposal for a new course of study must include estimated start-up costs and projected annual costs. All new courses or major modifications to existing courses must be approved by the Superintendent and trustees.

Curriculum guides will be prepared for each course of study offered within the School District. A guide will consist of:

- a. detailed content standards, learner results, assessment requirements, pacing guide, and available resources;
  - -chart of the learner results;
  - -approved assessment documents;
  - -course outlines;
  - -essential instructional practices.

All classes shall be accessible to students regardless of race, color, national origin, gender, handicapping status or religion.

Each teacher shall conduct the assigned course of study in accordance with the guide. Any deviation from the course of study must be temporary, presented to the principal in writing and have the principal's approval. Principals will forward proposed deviations from the course of study to the Assistant Superintendent.

#### **High School Graduation Requirements**

Each student Students who has have successfully completed an instructional program appropriate to his/her their interests and needs shall be awarded a diploma by Bozeman School District No. 7. The Board shall award one of the diplomas, as described below, to every high school student enrolled in the District who meets the requirements as established herein. The official transcript will indicate the specific courses taken and level of achievement.

The Board shall establish graduation requirements as recommended by the superintendent which, as a minimum, satisfy those established by the Board of Public Education. Generally, any change in graduation requirements promulgated by the Board will become effective for the next class to enter 9th grade. Exceptions to this general rule may be made where it is determined by the Board that the proposed change in graduation requirements will not have negative effect on students already in grades 9-12.

The superintendent shall develop procedures and practices for implementing this policy.

Graduation Requirements - Bozeman High School Bozeman School District Diploma

To graduate from Bozeman High School Bozeman School District, a student must have satisfactorily completed the last semester prior to his/her graduation as a Bozeman High School Bozeman School District student. To graduate from the Bridger Charter Academy Alternative Program, a student must have satisfactorily completed the last quarter prior to his/her graduation. Highly unusual exceptions may be considered by the principal/administrator.

#### **WORLD GEOGRAPHY SS130**

1.0 (YEAR)

Prerequisite: None Grade Level(s): 9

How does where you live influence how you live? How are humans affected by changes they make to their physical environment? Is globalization a positive trend? Freshman World Geography is an introductory high school level social studies course that will emphasize building necessary social studies skills while exploring the cultural, political and economic characteristics of regions around the world. Students will explore Africa, Asia, Middle East, North and South America, Europe and Australia while gaining valuable information about current events and our increasingly globalized world-

Credit Type: SS1

#### **WORLD HISTORY SS200**

1.0 (YEAR)

Prerequisite: None Grade Level(s): 10, 11, 12

"One faces the future with one's past," writer Pearl S. Buck once wrote. In this World History class, we will connect the past with the present, and look to the future. Join classmates in the exploration of ancient and modern civilizations, and discover their contributions to today's global community. Using primary and secondary sources, cooperative learning, student presentations, analytical writing and a wide range of hands on activities, the course will produce a more knowledgeable and productive global citizen. Although it is not required for graduation from BHS, many colleges and universities require World History for admission.

## **EURO- Replaced with WORLD** AP® EUROPEAN HISTORY (COMBO) SS225

1.0 (YEAR)

Prerequisite: English I and Teacher Signature

Grade Level(s): 10

The student who takes this AP® course should have strong reading comprehension and writing skills and will be expected to demonstrate leadership in the classroom setting. This course combines the chronological study of European history and literature in an integrated program, beginning with the Middle Ages in Europe and working to the present day. Students will write college level essays, creative works and a research paper. They also refine critical thinking, speaking, listening, reading and group interactive skills throughout the year. This course is designed to meet the objectives of English II and AP® European History in a course taught by one member of the English dept. and one member of the Social Studies dept. In addition to providing students with the opportunity to explore the connections between two academic disciplines, emphasis will be placed on preparing for the

## SOCIAL STUDIES PROPOSED NEW COURSE NAME/DESCRIPTION 2019-2020

#### **WORLD GEOGRAPHY SS130**

1.0 (YEAR)

Prereauisite: None Grade Level(s): 9

Freshman World Geography is an introductory social studies course. This course emphasizes geographic reasoning based on knowledge of Earth's physical and human features, including the locations of places and regions, the distribution of landforms and water bodies, and historic changes in political boundaries, economic activities, and cultures. Thinking geographically requires knowing that the world is a set of complex ecosystems interacting at multiple scales that structure the spatial patterns and processes that influence our daily lives. Geographic reasoning brings societies and nature under the lens of spatial analysis, and aids in personal and societal decision making and problem solving. Regions explored will include Canada and the United States, Latin America, Africa, Europe and Russia, Southwest and Central Asia, Monsoon Asia, and Oceania and Antarctica. Students will investigate local and global problems, identify personal connections, and seek solutions to current local, regional, and world challenges. This course is required for graduation.

Credit Type: SS1

#### **WORLD HISTORY** SS200

1.0 (YEAR)

Prereauisite: None Grade Level(s): 10, 11, 12

World History is a yearlong Sophomore level social studies elective. In World History students will connect the past with the present, and look to the future, of their own lives and the entire human race. Students will explore cultures across time to discover their contributions, context, and significance in politics. philosophy, technology, economics, literature and the arts. Students will use primary and secondary sources, cooperative learning, presentations, and analytical writing, historical thinking and research skills to gain a greater appreciation of various global cultures.

~ Although not required for graduation from BHS, many colleges/universities require World History for admission.

Credit Type: GEN

#### AP® WORLD HISTORY (COMBO) SS225

1.0 (YEAR)

Prerequisite: English I and Teacher Signature

Grade Level(s): 10

Advanced Placement World History/Honors English II (combo) qualifies as a sophomore level elective class that is team-taught in a two-period block by an English teacher and a Social Studies teacher. This cross-curricular class is a chronological study of World history that integrates literature, art, music, and architecture in order to convey a more complex and sophisticated portrait of the world's fascinating past and rich cultural heritage. During the year, students produce college-level essays, document-based responses, and research projects. They also refine critical historical thinking, speaking, listening, reading, and group interactive skills. Emphasis will be placed on preparing for the Advanced Placement World History exam, which allows for university/college credit in most post-secondary programs.

Credit Type: GEN

(optional) Advanced Placement European History exam, which allows for university/college credit in most post-secondary programs. This class will be taught in a two hour block (1 credit English II Honors and 1 credit AP® European History).

Credit Type: GEN

#### U.S. HISTORY (COMBO) SS375

1.0 (YEAR)

Prerequisite: English II Grade Level(s): 11

What is worth remembering? How do we make distinctions between "us" and "them"? How do texts contribute to the cultural and societal values of the time period in which they are written? Students examine questions such as these in American Studies, a class that approaches the study of American literature and American history both chronologically and thematically. This integration enriches the learning experience: just as it is impossible to undertake a meaningful study of American history without understanding the poetry and prose that both drive and chronicle it, one cannot truly comprehend the power behind the words of America's writers without understanding the context of the times in which they wrote. Students gain a greater appreciation of the men and women who, in unique times and through the force of their voices and determination, helped make America the country it is today. Communication skills will be enhanced in this team-taught, two-period class, which fulfills the History and English requirements for junior year (1 credit English III, and 1 credit U.S. History). Required course for all juniors/exception-see AP US History Combo.

Credit Type: USHIST

#### AP® U.S. HISTORY (COMBO) SS385

1.0 (YEAR)

Prerequisite: English II and Teacher Signature

Grade Level(s): 11

Our American culture is based on our tradition, our values, our way of thinking, and our way of life. Experiencing past events through history, literature, art, and music should lead to a greater understanding and appreciation for that heritage. This course offers students the opportunity for building these connections through a chronological study of U.S. history, literature, and culture in an integrated class taught by one member of the Social Studies dept. and one number of the English dept. During the year, students produce college level essays, document based responses, and research projects. They also refine critical thinking, speaking, listening, reading and group interactive skills. Emphasis will be placed on preparing for the Advanced Placement® U.S. History exam, which allows for university/college credit in most post secondary programs. The course fulfills the history and English requirements for junior year and will be taught in a two hour block (1 credit Honors English III, and 1 credit AP® U.S. History).

Credit Type: USHIST

#### U.S. GOVERNMENT SS400

0.5 (SEM)

Prerequisite: Grade Level

Grade Level(s): 12

This course meets the U.S. Government requirement for graduation. Topics of interest that are covered in the course are: What does freedom mean to you? What are your civil rights and civil liberties? What are the responsibilities of citizenship? Can the police search—your car in the school parking lot? Why should you vote? How does the Constitution affect your daily life? Who are your Congressmen? What do they do for you and Montana? These and many more questions are answered in U.S. Government.

Credit Type: USGOV

#### U.S. HISTORY (COMBO) SS375

1.0 (YEAR)

Prerequisite: English II Grade Level(s): 11

US History/English III Combo is a required junior level class that is team-taught in a two-period block by an English teacher and a Social Studies teacher. This cross-curricular class integrates the study of American literature and American history so that students can develop more sophisticated understandings of the past while improving their historical thinking, research, and communication skills. Just as it is impossible to undertake a meaningful study of American history without understanding the poetry and prose that both drive and chronicle it, one cannot truly comprehend the power behind the words of America's writers without understanding the context of the times in which they wrote. Students will investigate significant individuals, groups, places, documents, literature, and ideas to gain a greater appreciation for the American experience. This class fulfills the History and English requirements for junior year (1 credit English III, and 1 credit U.S. History). Required course for all juniors/exception-see AP US History Combo.

Credit Type: USHIST

#### AP® U.S. HISTORY (COMBO) SS385

1.0 (YEAR)

Prerequisite: English II and Teacher Signature

Grade Level(s): 11

Advanced Placement US History/Honors English III (combo) qualifies as a required junior level class that is team-taught in a two-period block by an English teacher and a Social Studies teacher. This cross-curricular class is a chronological study of United States history that integrates literature, art, music, and architecture in order to convey a more complex and sophisticated portrait of America's fascinating past and rich cultural heritage. During the year, students produce college-level essays, document-based responses, and research projects. They also refine critical historical thinking, speaking, listening, reading and group interactive skills. Emphasis will be placed on preparing for the Advanced Placement U.S. History exam, which allows for university/college credit in most post-secondary programs. The course fulfills the history and English requirements for junior year. (1 credit Honors English III, and 1 credit AP U.S. History).

Credit Type: USHIST

#### U.S. GOVERNMENT SS400

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

US Government is a senior level capstone course. This course emphasizes that government is a means for addressing common public problems by utilizing the political system established by the U.S. Constitution. Students will understand the importance of the founding principles of democracy, comparative political and economic systems, the media's role in the political process, the branches of federal government, and civil rights and civil liberties. Students will also explore the techniques available to citizens for preserving and changing society through productive civic engagement. Students will address public issues individually and collaboratively in order to maintain and strengthen communities through informed practices such as voting, volunteering, and civic action. This is a required course for graduation.

Credit Type: USGOV

#### AP® U.S. GOVERNMENT & POLITICS SS522

0.5 (SEM - FALL)

Prerequisite: Grade Level Grade Level(s): 12

Should the government bail out failing industries? What is pork barrel legislation and why don't people like it? Should we redistribute taxes to pay for people on welfare? What is happening with social security? Will you have any money by the time you retire? Should flag burning be legal? What is a polling package? How much influence do the media and special interest groups have in our political system? Are executive orders within the parameters of the Constitution? These and many other questions will be discussed in Advanced Placement U.S. Government and Politics. AP® U.S. Government is a college-level course that meets the requirements for graduation. The course is intended for the student who is interested in government and politics and who wishes to engage in a critical evaluation of the U.S. federal system and current issues our nation faces. The course will analyze the various entities of government as well as the many players within and outside the system. Upon successful completion of this course, students will be prepared for the College Board AP® U.S. Government and Politics exam in May.

Credit Type: USGOV

#### **ECONOMICS** SS420

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

Economics is a semester course that meets the senior elective requirement. Topics of interest that are covered in this course are: What makes a dollar worth a dollar? Why does working on a garbage truck guarantee you a wage differential? Does private ownership of wild elephants in Africa mean they will survive? Does international trade jeopardize American jobs? Should organs be sold on the open market? What does crime cost? Are monopolies illegal? If so, why? Are sweatshops a bad thing? If I can sell my pollution, does it help solve global warming? Guns vs. Butter? Say what? Are taxes good, bad, indifferent or just confusing? Should fatty foods be taxed by the government to reduce consumption? These and many more questions are answered in Economics.

Credit Type: SSEL

#### **AP® MICROECONOMICS** SS530

0.5 (SEM)

Prerequisite: Grade Level
Grade Level(s): 12

Microeconomics is a semester course that meets the senior elective requirement. The purpose of an AP® course in microeconomics is to give students a thorough understanding of the principles of economics that apply to the decisions of individuals both consumers and producers within the larger economic system. It places primary emphasis on the nature and functions of product markets, and includes the study of factor markets and the role of government in promoting greater efficiency and equity in the economy. The course will be divided into five units: Basic Economic Concepts, Supply and Demand, The Theory of the Firm, Factor Markets, and The Role of the Government.

Credit Type: SSEL

#### **HUMAN GEOGRAPHY** SS430

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

Human Geography is a semester course that meets the senior elective requirement. Human Geography is the study of the interaction between humans and their environment and will encourage you to investigate the

#### AP® U.S. GOVERNMENT & POLITICS SS522

0.5 (SEM - FALL)

Prerequisite: Grade Level Grade Level(s): 12

AP U.S. Government and Politics provides a college-level, nonpartisan introduction to key political concepts, ideas, institutions, policies, interactions, roles, and behaviors that characterize the constitutional system and political culture of the United States. Students will study U.S. foundational documents, Supreme Court decisions, and other texts and visuals to gain an understanding of the relationships and interactions among political institutions, processes, and behaviors. They will also engage in disciplinary practices that require them to read and interpret data, make comparisons and applications, and develop evidence-based arguments. In addition, they will complete a political science research or applied civics project.

Credit Type: USGOV

#### **ECONOMICS** SS420

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

Economics is a semester course that meets the senior elective requirement. This course will emphasize an understanding of the ways in which individuals, businesses, governments, and societies make decisions to allocate human capital, physical capital, and natural resources among alternative uses. This course provides students with the concepts and tools necessary for an economic way of thinking and helps students understand the interaction of buyers and sellers in markets, workings of the national economy, and interactions within the global marketplace.

Credit Type: SSEL

#### **AP® MICROECONOMICS** SS530

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

Microeconomics is a semester course that meets the senior elective requirement. The purpose of an AP course in microeconomics is to give students a thorough understanding of the principles of economics that apply to the decisions of consumers, producers, and businesses on their allocation of human capital, physical capital, and natural resources among alternative uses within the larger economy. Emphasis will be placed on preparing for the Advanced Placement Microeconomics Exam which allows for university/college credit in most post-secondary programs.

#### **HUMAN GEOGRAPHY SS430**

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 12

Human Geography is a semester course that meets the senior elective requirement. Human Geography is the study of the interaction between humans and their environment and will encourage you to investigate the world. The main questions we will ask in the course are: What is where, why there, and why care? Law & Justice focuses on the legal element of our established government and serves as an introductory course for the law and legal systems within the United States. The scope of content for this course includes Constitutional Law, civil law, criminal law, the criminal justice process, as well as other topics based upon student interest. We will use case studies, individual research, group discussions, debates, field trips, guest speakers, and mock trials throughout the course in order to reach this goal. Ducling opinions and lively debate will be the norm in this course making the class exciting, relevant, and applicable.

#### **PSYCHOLOGY I SS320**

0.5 (SEM)

Prerequisite: Grade Level Grade Level(s): 11, 12

Psychology does not meet the Social Studies senior elective requirement for graduation. Psychology is defined as the study of human behavior and mental processes. The course begins with the earliest ideas concerning causes of human behavior, describes Sigmund Freud's theories, movies into the behavior theories from the 1950s, and then presents current understandings of the brain and biological causes of behavior. Other areas of study include abnormal psychology, social psychology and states of consciousness, which includes the study of sleep and dreams. This course is not intended for students planning to enroll in AP Psychology.

#### **AP® PSYCHOLOGY** SS535

1.0 (YEAR)

Prerequisite: Grade Level Grade Level(s): 11, 12

What do learning, stress, mob behavior, psychological disorders, neurotransmitters, research methods, drug addiction, Sigmund Freud and Skinner's rats have in common? How do humans develop and change throughout life? Why do we remember some things and forget others? These questions represent several units in the AP® Psychology course. While this course is designed to be equivalent to an introductory college course, an emphasis is developed on understanding and applying key psychological facts and principles through reading, discussion, writing and exercises. College credit may be earned with the successful completion of the AP® Exam. AP® Psychology does not meet the Social Studies senior elective requirement for graduation.

Other areas of study include motivation, emotion, learning, and memory. This course is not intended for students planning to enroll in AP Psychology.

Psychological knowledge enhances our understanding of human development, emotion and motivation, cognition, learning processes. perceptual systems and sociocultural interactions. College credit may be earned with the successful completion of the AP Exam. AP Psychology does not meet the Social Studies senior elective requirement for graduation.

#### ISSUE:

Approval of revision to District Policy #3310, Student Discipline to include language pertaining to no contact agreements and restraining orders.

#### FACTS:

1. The revision was presented to the Board on November 12, 2018. There were no suggested changes.

2. The proposed revision to District Policy #3310 stems from the need to clarify school responsibilities for enforcing either school no contact agreements or restraining orders initiated by the court. Restraining orders are also enforced by local police.

#### **SUPERINTENDENT'S RECOMMENDATION:**

It is recommended that the Board approve the revision to District Policy #3310, Student Discipline, as presented.

#### OTHER ALTERNATIVES:

- 1. Do not approve.
- 2. Request additional revisions.

#### **DISCUSSION:**

Principals and counselors sometimes utilize "no contact contracts" when students need physical separation. Courts sometime impose restraining orders. Both of these situations occur at all grade level bands (K-12) and policy language provides transparency to students and families about expectations in the schools. This proposed policy revision supports Goal Area 4 of the Long Range Strategic Plan, Student and Staff Safety/Health/Welfare: Bozeman Public Schools has effective systems in place for students and staff to learn and work in a safe and healthy environment.

#### **STUDENTS**

#### Student Discipline

The Board grants authority to a teacher or principal to hold a student to strict accountability for disorderly conduct in school, on the way to or from school, or during intermission or recess.

Disciplinary action may be taken against any student guilty of gross disobedience or misconduct, including but not limited to instances set forth below:

- Using, possessing, distributing, purchasing, or selling tobacco products, including alternative nicotine and vapor products as defined in 16-11-302, MCA.
- Using, possessing, distributing, purchasing, or selling alcoholic beverages including powdered alcohol.
   Students who may be under the influence of alcohol will not be permitted to attend school functions and will be treated as though they had alcohol in their possession.
- Using, possessing, distributing, purchasing, or selling drug paraphernalia, illegal drugs, controlled substances, or any substance which is represented to be or looks like a narcotic drug, hallucinogenic drug, amphetamine, barbiturate, marijuana, alcoholic beverage, stimulant, depressant, or intoxicant of any kind, including such substances that contain chemicals which produce the same effect of illegal substances including but not limited to Spice and K2. Students who may be under the influence of such substances will not be permitted to attend school functions and will be treated as though they had drugs in their possession.
- Using, possessing, controlling, or transferring a weapon in violation of the "Possession of Weapons other than Firearms" section in policy 3311.
- Using, possessing, controlling, or transferring any object that reasonably could be considered or used as a weapon as referred to in policy 3311.
- Disobeying directives from staff members or school officials or disobeying rules and regulations governing student conduct.
- Using violence, force, noise, coercion, threats, intimidation, fear, or other comparable conduct toward anyone or urging other students to engage in such conduct.
- Causing or attempting to cause damage to, or stealing or attempting to steal, school property or another person's property.
- Engaging in any activity that constitutes an interference with school purposes or an educational function or any other disruptive activity.
- Unexcused absenteeism. Truancy statutes and Board policy will be utilized for chronic and habitual truants.
- Hazing or bullying.
- Forging any signature or making any false entry or attempting to authorize any document used or intended to be used in connection with the operation of a school.
- Violating a "no contact agreement" or violating court orders including restraining orders obtained by other students or staff.

These grounds stated above for disciplinary action apply whenever a student's conduct is reasonably related to school or school activities, including but not limited to the circumstances set forth below:

- On, or within sight of, school grounds before, during, or after school hours or at any other time when school is being used by a school group.
- Off school grounds at a school-sponsored activity or event or any activity or event that bears a reasonable relationship to school.
- Travel to and from school or a school activity, function, or event.
- Anywhere conduct may reasonably be considered to be a threat or an attempted intimidation of a staff member or an interference with school purposes or an educational function.

## **Disciplinary Measures**

Disciplinary measures include but are not limited to:

- **Expulsion**
- Alternative to Expulsion
- Suspension
- Detention, including Saturday school
- Clean-up duty
- Loss of student privileges
- Loss of bus privileges
- Notification to juvenile authorities and/or police
- Restitution for damages to school property

No District employee or person engaged by the District may inflict or cause to be inflicted corporal punishment on a student. Corporal punishment does not include reasonable force District personnel are permitted to use as needed to maintain safety for other students, school personnel, or other persons or for the purpose of self-defense.

## **Delegation of Authority**

The Board grants authority to any teacher and to any other school personnel to impose on students under their charge any disciplinary measure, other than suspension or expulsion, in-school suspension or alternative to expulsion, that is appropriate and in accordance with policies and rules on student discipline. The Board authorizes teachers to remove students from classrooms for disruptive behavior.

## ISSUE:

Approval of revisions to Policy #2410, High School Graduation Requirements, to reflect development of a Bozeman School District Diploma (23 credits), a Special Circumstance Diploma (23 credits) and a Bozeman School District Diploma with Distinction (25 credits).

#### FACTS:

- 1. The revision was presented to the Board of November 12, 2018. There were no suggested changes.
- 2. The High School Programming Committee met over a series of meetings (November 15, 2017, December 19, 2017, January 31, 2018, February 13, 2018, March 21, 2018, April 17, 2018, and May 16, 2018). The Programming Committee discussed three main topics: Academic Programming, Scheduling and Graduation Requirements.
- 3. The Graduation Requirements Subcommittee was tasked with reviewing and validating current graduation requirements with the lens of preparing students to succeed in postsecondary education and careers of the future, and discussing the Honors Diploma to determine if it was meeting the intended purpose and benefiting students for postsecondary education and careers.
- 4. As a result of the subcommittee work, the Programming Committee achieved consensus on the development of a Bozeman School District Diploma (23 credits), a Special Circumstance Diploma (23 credits) and a Bozeman School District Diploma with Distinction (25 credits).
- 5. This consensus recommendation was presented to the Board of Trustees for directional support at the August 13, 2018 meeting.
- 6. Additional work on diploma requirements was completed this fall.
- 7. The term Bozeman High School should be changed to Bozeman School District to be inclusive of two high schools.
- 8. The Bozeman School District Diploma and the Bozeman School District Honors Diploma will be available to current students through the graduating class of 2022.
- 9. A Special Circumstance Diploma is proposed to be available for students beginning in the 2018-19 school year.

10. The Bozeman School District Diploma and the Bozeman School District Diploma with Distinction will be implemented with the incoming Freshman class in the Fall of 2019.

## SUPERINTENDENT'S RECOMMENDATION:

It is recommended that the Board approve the revision to Policy #2410, High School Graduation Requirements, as presented.

## **DISCUSSION:**

The diploma distinctions will recognize students' talents and interests beyond the traditional college-prep track and focus on course selections to support different paths to graduation.

#### **High School Graduation Requirements**

Each student Students who has have successfully completed an instructional program appropriate to his/her their interests and needs shall be awarded a diploma by Bozeman School District No. 7. The Board shall award one of the diplomas, as described below, to every high school student enrolled in the District who meets the requirements as established herein. The official transcript will indicate the specific courses taken and level of achievement.

The Board shall establish graduation requirements as recommended by the superintendent which, as a minimum, satisfy those established by the Board of Public Education. Generally, any change in graduation requirements promulgated by the Board will become effective for the next class to enter 9th grade. Exceptions to this general rule may be made where it is determined by the Board that the proposed change in graduation requirements will not have negative effect on students already in grades 9-12.

The superintendent shall develop procedures and practices for implementing this policy.

Graduation Requirements - Bozeman High School Bozeman School District Diploma

To graduate from Bozeman High School Bozeman School District, a student must have satisfactorily completed the last semester prior to his/her graduation as a Bozeman High School Bozeman School District student. To graduate from the Bridger Charter Academy Alternative Program, a student must have satisfactorily completed the last quarter prior to his/her graduation. Highly unusual exceptions may be considered by the principal/administrator.

- (1) As a minimum, a school district's requirements for graduation shall include a total of 20 units of study that enable all students to meet the content standards and content-specific grade-level learning progressions.
- (2) In order to meet the content and performance standards, the following 13 units shall be part of the 20 units required for all students to graduate:
  - (a) 4 units of English language arts;
  - (b) 2 units of mathematics;
  - (c) 2 units of social studies;
  - (d) 2 units of science;
  - (e) 1 unit of health enhancement, with 1/2 unit each year for two years;
  - (f) 1 unit of arts; and
  - (g) 1 unit of career and technical education.
- (3) Units of credit earned in any Montana high school accredited by the Board of Public Education shall be accepted by all Montana high schools.
- (4) In accordance with the policies of the local board of trustees, students may be graduated from high school with less than four years enrollment.

#### **HUMAN RESOURCES**

<u>Sexual Harassment, /Sexual Intimidation, and Misconduct in the Workplace</u> (For Students and Employees)

Bozeman Public School District No. 7 is committed to a positive and productive working and learning environment free of discrimination. Sexual harassment, intimidation, and misconduct are expressly prohibited. These types of dDiscrimination adversely affects morale and interferes with employee and student ability to work and learn. The District prohibits sexual harassment or sexual intimidation of its employees or students, whether committed by a worker, co-worker, supervisor, subordinate, contractor, volunteer or student, and finds such behavior cause for disciplinary action. This policy applies to employees, students and volunteers on or off District property as they carry out their responsibilities.

Furthermore, the District prohibits retaliation against any employee or student because he or she has made a report of alleged sexual harassment or against any employee or student who has testified, assisted, or participated in the investigation of a report. Retaliation includes, but is not limited to, any form of intimidation, reprisal, or adverse pressure. Retaliation is itself a violation of federal and state regulations prohibiting discrimination and will lead to disciplinary action against the offender.

The Bozeman School District understands that District employees and students have the right to associate freely. However, the District further understands the necessity to protect children. Students are a captive audience and employees have a degree of control and power over students. Based upon these and other relevant factors, the District prohibits employees from dating students. If a teacher or other staff member violates this policy, disciplinary action will be taken, up to and including termination.

#### **DEFINITIONS** Definitions

"Sexual harassment" means unwelcome sexual advances, unwelcome requests for sexual favors, and other unwelcome verbal or physical conduct of a sexual nature when:

- submission is made either explicitly or implicitly a term or condition of an individual's employment or education;
- submission to or rejection of that conduct by an individual is used as a factor in decisions affecting that individual's employment or education; or
- that conduct has the purpose or effect of unreasonably interfering with an individual's employment or education, or of creating an intimidating, hostile or offensive employment or educational environment.

"Sexual intimidation" means any unreasonable behavior, verbal or nonverbal, which has the effect of subjecting members of either sex to humiliation, embarrassment or discomfort because of their gender when unwelcome sexually-oriented jokes, innuendoes, obscenities, pictures/posters or any action with sexual connotation make a student or employee feel uncomfortable; or any aggressive, harassing behavior in the workplace or school that affects working or learning, whether or not sexual in connotation, is directed toward an individual based on their sex.

The following are examples of sexual harassment or sexual intimidation:

- sexual advances which are unwanted (this may include situations which began as reciprocal attractions, but later ceased to be reciprocal);
- sexual gestures, verbal abuse, sexually-oriented jokes, innuendo or obscenities;
- . displaying of sexually suggestive objects, pictures, cartoons, or posters;

- . unwelcome sexually suggestive letters, notes or invitations;
- employment or educational benefits affected in exchange for sexual favors;

.

- —sexually related hazing or daring to perform unsafe acts in work or learning environments, with these particularly directed toward students or employees in nontraditional settings;
- physical conduct such as assault, attempted rape, impeding or blocking movement, or unwelcome touching.

"Sexual misconduct" includes any actual or attempted sexual contact with a minor or student, and any actual or attempted violation of criminal laws contained in Montana Code Annotated, Title 45, Chapter 5, including but not limited to laws addressing sexual intercourse without consent, sexual assault, sexual abuse, sexual exploitation, and indecent exposure.

#### **PREVENTION**Prevention

It is the policy of this District to provide periodic in-service education and training about sexual harassment and sexual intimidation for employees and students. The in-service education and training may include the following:

- definitions of sexual harassment and sexual intimidation, and overview of relevant state and federal laws:
- . identification of harassing behaviors by students and/or staff;
- . age-specific prevention techniques;
- . coping techniques for self and others;
- training in positive, age-appropriate communication alternatives to harassment;
- . grievance procedures available to employees and students.

#### **REPORTING** Reporting

A student or employee who believes they may have been sexually harassed or sexually intimidated <u>or subjected to sexual misconduct</u> should contact a teacher, counselor, the Human Resources Director, or the first level supervisor who is not involved in the alleged harassment. Persons who feel they are being harassed or intimidated should take the following steps:

- . Linform the individual that his/her behavior is unwelcome, offensive or inappropriate. DO NOT assume or hope that the problem will go away.
- . Neotify a teacher, counselor, the Human Resources Director or an administrator right away. Early reporting assists any investigation.
- . Request a copy of the District's sexual harassment policy so that reporting processes are clear.
- . <u>Kkeep</u> notes. Keep a record of dates, times, places, witnesses and descriptions of each incident. Save all notes or records in a safe place.

Complainants are permitted to have a friend or advisor present with them for moral support during any stage of the investigation of the report.

Any employee or volunteer who becomes aware of possible sexual misconduct shall immediately report the misconduct to an administrator verbally and in writing. Employees who knowingly condone or fail to report or assist a student to take action to remediate such behavior of sexual harassment or intimidation may themselves be subject to discipline.

An investigation will be promptly initiated. After the investigation:

5012 (cont'd)

- Any District employee who is determined to have engaged in sexual harassment will be subject to disciplinary action up to and including discharge. The District will also report sexual misconduct to the Montana Board of Public Education, which may result in loss of licensure.
- Any student of the District who is determined to have engaged in sexual harassment will be subject
  to disciplinary action, including but not limited to suspension and expulsion consistent with the
  District's discipline policy.
- Any person who knowingly makes a false accusation regarding sexual harassment likewise will be subject to disciplinary action up to and including discharge with regard to employees or suspension and expulsion with regard to students.

#### **Record Retention**

A written record will be kept of each reported incident, including the written report, investigation, findings, referrals to other entities, and disciplinary and/or remedial action taken. Reference to this retained file may be placed in the personnel file of the perpetrator and/or the permanent file of the student, at the discretion of administration.

All employees and students have a responsibility to maintain a positive work and learning environment by reporting all incidents or rumors of sexual harassment or sexual intimidation involving themselves or others. Students and staff are encouraged to use the reporting procedure set forth in this policy. An individual with a complaint alleging a violation of this policy should follow the Uniform Complaint Procedure.

#### PERSONNEL

#### Prohibition on Aiding Sexual Abuse

The district prohibits any employee, contractor or agent from assisting a school employee, contractor or agent in obtaining a new job if the individual or district knows or has probable cause to believe that such school employee, contractor or agent engaged in sexual misconduct regarding a minor or a student in violation of the law. This prohibition does not include the routine transmission of administrative and personnel files.

This prohibition does not apply under certain conditions specified by the Every Student Succeeds Act (ESSA) such as:

- 1. The matter has been reported to law enforcement authorities and it has been officially closed or the school officials have been notified by the prosecutor or police after an investigation that there is insufficient information to establish probable cause, or;
- 2. The individual has been acquitted or otherwise cleared of the alleged misconduct, or;
- 3. The case remains open without charges for more than 4 years after the information was reported to a law enforcement agency.

#### ISSUE:

Shall the Board of Trustees approve the bid to install two 50 kW photovoltaic solar arrays?

## FACTS:

- 1. The board approved a NorthWestern Energy Universal System Benefits grant application on November 13, 2017.
- 2. The District received a grant award amount totaling \$48,005 on May 7, 2018.
- 3. Bids were publicly advertised per state statues in August and September 2018 per MCA 20-9-204. Four bids were received on September 14, 2018. Following the bid opening there became significant confusion over the product the apparent low bidder intended to use. The Board rejected all of the original bids and asked administration to make adjustments to the Request for Proposals and rebid the project.
- 4. Bids were publicly re-advertised in November per state statutes and publicly opened on November 20, 2018.
- 5. Three bids were received per the attached Bid Tabulation.

#### SUPERINTENDENT'S RECOMMENDATION:

It is recommended to approve the bid for the installation of 50kW solar systems at Hyalite and Meadowlark Elementary Schools and authorize administration to enter into a contract with Bozeman Green Build for \$108,644.

#### OTHER ALTERNATIVES:

Suggest other contractors or contract modifications.

#### **DISCUSSION:**

Prior to seeking funding from the Universal System Benefits Renewable Energy Program (USB-RE), BSD7 successfully bid a 49.80 kW system for inclusion with the renovation and expansion efforts at Sacajawea Middle School (SMS). This system was primarily funded by a student driven initiative for the development of a renewable energy system at the middle school in conjunction with the recent project. The original proposal sought funding for four new PV-Solar installations, each of which will not exceed 50 kW's, at the following schools: Emily Dickinson Elementary, Hyalite Elementary, Meadowlark Elementary and Morning Star Elementary.

Bozeman Public Schools initially proposed an individual cost share at each location of 30%. The funding offset for each install would come from surplus funds available from the SMS initiative in addition to current building reserve funds. Per the grant award, the NWE-USB award only provided grant funding for one location. With this provided funding, along with the available District funds, it was decided to proceed with installations at two identified locations.

Design specifications provide for an informational kiosk at each location to further the understanding on how much energy is being produced in relationship to the daily offset. Furthermore, the data collected will be made available to teachers and/or pupils within the District for educational purposes beyond the selected locations. Tours can be arranged to show any and all components of each system for other interested school Districts upon request. It will be the District's intent to highlight the benefit of the solar system and present our findings at an appropriate educational conference or seminar within the state.

#### **DISCUSSION:**

Policy #6121 provides guidance for the development of the organizational structure of our District. Procedure #6121P provides detail regarding the current organizational structure. As needed, administration has made changes to the organizational structure (6121P), when those changes did not result in additional personnel.

As our district grows, we anticipate the need to reexamine our organizational structure and determine if changes need to be made. Our leadership team has discussed the organizational structure. We have identified areas of strength with our structure and areas of needed improvement.

This time has been set aside to engage the Board in a discussion regarding our administrative structure and our District organizational chart. Potential changes to the structure could be brought to the Board for approval as a singular action item at a future Board meeting.

#### **ADMINISTRATION**

#### School District Organization

The organization of the school District positions of employment for purposes of supervision, services, leadership, administration of school board policy, and all other operational tasks shall be on a "line and staff" basis. School District personnel occupying these positions of employment shall carry out their duties and responsibilities on the basis of the line and staff organizations.


The "line" portion of the organization is the vertical line of positions, starting from the top with the Board of Trustees and flowing down through to the teachers. This is the line of authority within the School District organization and it is the focal point of all operational functions.

The "staff" portion of the organization are those positions horizontally placed from the line organization. The primary function of the staff positions is to service and support the line organizations.

The purpose of the organization of the school district positions of employment on a line and staff organization basis are for the orderly and logical conduct of business. Under this administrative structure, the conduct of school district affairs may logically be carried out from the Board of Trustees to the teachers and students. This line of authority should be utilized to communicate actions of the School District and for the management of the School District. In addition to this, it should be used for the coordination of the organizational efforts, acts of leadership, and any other conduct of business.

#### **Crowdfunding Proposals**

Bozeman School employees and District-sponsored groups may raise funds or acquire materials to benefit the District via crowdfunding platforms that have been approved by the Superintendent or Designee.

All crowdfunding proposals must be approved in advance of soliciting funds. Further, any crowdfunding requiring Board authorization or matching funds—including in-kind contributions—must be presented to the Board for authorization.

Only employees and District-sponsored groups are permitted to operate under this policy. Individuals and non-District groups may not use the District's name, network, or infrastructure to conduct online fundraising.

The Superintendent will develop procedures to ensure the effective administration of this policy.
