DISCUSSION

- 5. Superintendent's Report
 - 5.1. Communications/Recognitions
 - 5.1.1. Each year, district employees are given a pin that represents that year's theme. Dr. Sever will personally deliver "Dream Big" pins to each employee as he visits sites in January.

- 5.1.2. The Board was invited to the MOT/Food Service Appreciation BBQ hosted by MOT at the Lincoln Cafeteria on Friday, December 17th at 1:30 pm.
- 5.1.3. Dr. Sever thanked the Board for delivering cookies and visiting the school sites. A thank you note from CVHS to the Governing Board was read. Mr. Bergstrom stated how nice it was to talk with the Technology Department.
- 5.1.4. District Leadership will be doing a study on the books Talk to Me and The Culture Question. These books focus on what we are already doing well and what we can do better.
- 5.1.5. Roosevelt staff was able to bless four families during Thanksgiving. The staff worked together and made donations to provide what the family needed.
- 5.1.6. At the recent Safety Committee meeting during the round table, all of the schools wanted to thank Mr. Danny McIntyre for the outstanding job he has done as Director of MOT in addressing and fixing safety issues on each school campus. They all stated that his response has been great and that he has taken care of problems when they occur. Thank you, Danny, for keeping our employees and students at Kingsburg Elementary safe!
- 5.1.7. All staff is now required to wear masks indoors beginning tomorrow, December 15th, through January 15th. We will be sending a notice to staff. We will contact our local legislature to keep the personal belief waiver for student/staff COVID vaccinations.

- 5.2.1. Mrs. Underwood and Mrs. LeBoeuf attended a conference recently for Food Services.
- 5.2.2. The Superintendent's Conference is at the end of January 2022.

6. Assistant Superintendent's Report

- 6.1. The CA Teaching Fellows contracts for approval on this agenda will provide us with two after school intervention programs at Lincoln and Reagan. It will run from after school until 6pm. They will provide many activities such as intervention, arts and crafts, and more. Some of these Teaching Fellows are people who want to be future teachers. The cost of the contract for Lincoln is a little more due to the earlier release time. There will be one site lead at each school and seven additional people. There's a 1:14 ratio if we have 100 students. The information will be going out to parents soon. It will be free for families and help our students recover some lost instruction time from COVID. Part of the student selection will be input from teachers, and we will also be prioritizing foster, EL, and homeless students.
- 6.2. We are continuing our PD focus on math. Our staff is enjoying working alongside teachers instead of being pulled out with subs.
- 6.3. We are ready to roll out our leader board for the Badge Project. In addition, we will be having some specialty days like "Badges for Burritos" and "Got Caught Wearing Badges." The Kingsburg Community Education Foundation will assist with the cost of these events. We have 1,777 badges completed to date. Stanislaus County has asked us to present with them at the CISC Conference in Monterey in February, and we are very excited about the opportunity.
- 6.4. Ellevation has asked us to do a podcast with them after hearing about our reading success.

7. Chief Business Official's Report

- 7.1. The Grounds Department is very thankful and happy with the new mower purchase.
- 7.2. 1,100 meals were served yesterday. This is the most so far this year. Mrs. LeBoeuf was able to get 20 more cases of trays. This will take us to the 3rd week in January. They are looking at more vendors and ordering what they can.
- 7.3. Thank you to the City of Kingsburg, Flix Productions, MOT, Food Service, Mrs. Vaquera, and Mr. Esparza for their help with the Lincoln School Holiday Program. Every student received a cookie and a drink when they got back on the bus. It was a wonderful morning that was enjoyed by all.

- 7.4. Reagan Basketball Courts- We have filled in the large cracks with hot asphalt by Don Berry Construction. The tripping hazards have all been filled in. This company went above and beyond with the leftover asphalt.
- 7.5. Preschool Gate- We had some students trying to get past the gate which created a safety issue. Our MOT department put a new gate together to keep these students safe.
- 7.6. The new Rafer cameras have been installed. The vape detectors will be installed this Thursday and Friday after school. There are two per restroom and they will be installed on the ceiling. The detectors will send a notification to the designated person when vaping occurs.
- 7.7. Island ceiling tiles were installed yesterday. It looks nice and clean. We will put a cabinet over the existing phone and wires in the corner of the classroom. The Board asked if the students could enter through the front door. Mr. Rodriguez will discuss this with Mrs. Regier to see if it is a possibility.
