Jeff Sprowles of Wise, Buckner, Sprowles & Associates, presented the audit report for the district as of June 30, 2018. Mr. Sprowles explained the audit report had a clean opinion for the year. The general fund balance ended at \$2,973,156 (\$2,813,091 unassigned and \$160,065 restricted-sick leave). The net change in fund balance for general fund was a decrease of \$646,977, but the balance is still healthy. He noted that Food Service had a good year with an increase in fund balance of around \$60,000. He said there were no findings on federal programs and the district expended \$3.3 million last year.
