To field modify each of the horizontal mullions that are mechanically fastened to the corner mullion (8 horizontals on each side of the corner mullion for each frames - 32 horizontal mullions in total). Also to field modify/fabricate interior closure aluminum to enclose the clearance from the back of the corner mullion to the steel column (the specified interior "snap" cover could not be used due to insufficient interior side clearance from the required corner mullion location to the face of each steel column).

Mrs. Harris reviewed the accountability scores for 2017-18, noting the changes in this transition year. Student achievement in each indicator (proficiency, separate academic indicator, growth, transition readiness, and graduation rate) were reviewed, along with comparisons to state averages. All Taylor County Schools were identified as "other" for 2017-18, which is the highest identification a Kentucky school/district could receive this year.
