H. ADMINISTRATIVE REPORTS

H.I. Melissa Long, Taylor County Primary Principal

Rationale:

Ms. Long was proud to share that the Primary Center has been given a Five Star rating from the Kentucky All STARS program. Kentucky All STARS is based on Kentucky's Early Childhood Standards and research-based indicators of quality. It recognizes programs that have made a commitment to continuous quality improvement. On the path toward higher quality, programs can benefit from supports including training, technical assistance and coaching. This is a rigorous process involving several walkthrough's from KDE. Teachers and administrators gather rigorous data to meet the standards. In KY this is the most prestigious rating.

H.II. Donna Williams, Taylor County Intermediate Principal

Rationale:

Ms. Williams said that they took their common assessments before spring break. They are using this data to target the standards students have not met. They are working on schedules for next year. They are adding teachers into self-paced and project based pathways. KPREP testing will begin May 4th. After the testing is over they will have a KPREP rally and award prizes based on student good faith efforts.

H.III. Danita Johnson, Taylor County Middle School Principal

Rationale:

Ms. Johnson talked about this year's goal for test scores being 75.6% Proficient. They reached that goal and set next year's goal to 80.6%. They had a Data Analysis day where students conducted Learning Styles Inventories and Multiple Intelligence Surveys and teachers developed guidelines and criteria for their classes. They are adding Peer Led courses for 7th & 8th grade, Blended instruction, Project Based Learning for 7th & 8th grade, Computer Science related courses for 6th, 7th and 8th grades, Digital and Visual Art courses and Specialty music/choir courses and PE.

H.IV. Laura Benningfield, Taylor County High School Principal

Rationale:

Ms. Benningfield announced that the new Cosmetology program will be opening next Monday. The Governor's wife and several others will be on hand for the ceremony. Also the greenhouse is preparing for their opening next week. They have begun Early Bird scheduling and had 125 students and parents on the first night.
