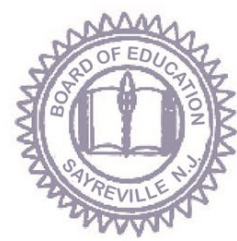

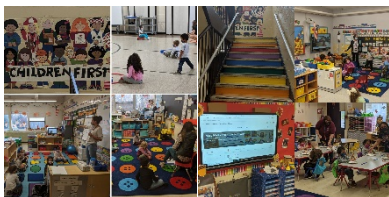
Talk Sup Week 11 Review and Preview

November 16, 2020

Good morning Sayreville. I hope you had a pleasant weekend. Welcome to another edition of *Talk Sup*. This week we will begin in-person instruction for all remaining students in the district. Today, students in grades 2-3 will join our K-1 students for in-person instruction at their elementary schools in Phase **2b**. Thus, all kindergarten through 3rd grade students in **Cohort B** will participate in in-person instruction **today (Monday, November 16th) and Thursday, November 19th** while **Cohort A** does so tomorrow (**Tuesday, November 17th) and Friday, November 20th**. Similarly, students at SUES, SMS, and SWMHS will also begin in-person instruction **tomorrow**, but will do so in Phase **2a** rather than 2b. Thus, 4-12th grade students in **Cohort A** will attend in-person instruction on **Tuesday, November 17th** while **Cohort B** does so on **Thursday, November 19th**.

Due to the Thanksgiving holiday recess next week, all **K-12** students in **Cohort B and C** (preschool and MD/BD self-contained classrooms) will participate in in-person instruction on **Monday, November 23rd** while **K-12 Cohort A and C** will participate in it on **Tuesday, November 24th**. Our tentative plan for the week of November 30th is to advance students in grades 4-5 to Phase 2b but keep students in grades 6-12 Cohort A&B in Phase 2a. 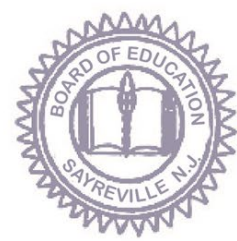

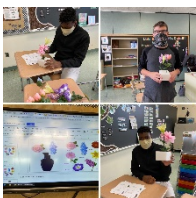

so masterfully taught both simultaneously. It was both impressive and inspiring and once again demonstrated to me how blessed I am to work in a district with the most dedicated and highly effective educators in New Jersey.

In addition, others have reported to me their fears about our students returning to our schools for in-person learning during this recent resurgence of COVID-19 cases. While I certainly understand these concerns and why parents would decide to switch their child to fulltime remote learning, according to Governor Murphy and other experts, schools are still safe for in-person instruction. The primary reason why the Governor and many others feel that they are safe is because of the extremely low transmission rate of COVID-19 in schools compared to other public and private business and social settings. In fact, although there have been students and staff members in our district who have been infected by the virus, all but one, which is somewhat questionable, have been infected by someone outside of our school district based upon the contact tracing that we have conducted. Thus, to date there have been almost no cases in our district where in which the virus has been transmitted from someone in our schools. This is consistent with the data being reported across the nation and world, as recently a neighboring state reported that their in-school transmission rate was 0.17% compared to 2.56% overall. Furthermore, in Europe, which is also experiencing a significant resurgence of the virus, with the exception of a few countries like Italy, nearly all are quarantining and shutting down all business **except for schools**, which remain open for in-person instruction due to the low transmission rate in them. Although there are many reasons for this, many credit the staff, students, and parents for this success due to their diligence in strictly adhering to personal protective procedures.

As a result, when we expand in-person instruction for all remaining students today and tomorrow, we expect all our students and staff to continue to follow all personal protective procedures outlined in our Restart of School Plan, particularly informing the school administration immediately if students or staff have tested positive or have been determined to be in close contact (within six feet for a total of 15 minutes) with a confirmed positive individual outside of school. Students and staff are also expected to stay home from school when required to quarantine or when not feeling well and experiencing symptoms on our health screening checklist. In fact, we have created flexibility in our attendance procedures that now allow for the parents of in-person learning students to keep them home and have them attend remotely instead when they are fearful or when their child is not feeling well. However, we will require parents in such cases to report this to their child’s teacher and/or the building administration at their school. Additionally, everyone in our schools is expected to maintain proper social distancing (**6-feet**) from others, wear masks at all times, and wash and/or sanitize their hands appropriately and often. Finally, we strongly encourage our staff and students to be regularly tested for COVID-19. While our staff is eligible to be tested each week at SWMHS, we recommend that parents utilize some of the community resources that are offering routine asymptomatic testing, such as Doctors Urgent Care in Sayreville and City MD Urgent Care in East Brunswick. Naturally when considering being tested, it is recommended that you consult with your primary healthcare provider. 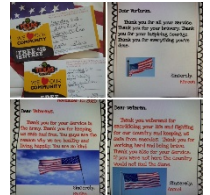

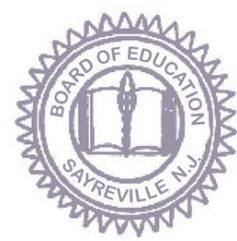

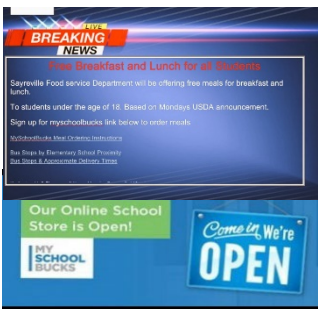
