### Talk Sup Week 24 Review and Preview

February 22, 2021

Good morning Sayreville! I hope you had a relaxing holiday weekend. Welcome to another edition of *Talk Sup Review and Preview*.

There are no new COVID-19 positive cases to report to you since my broadcast email last Thursday. For the most up to date information on the number of individuals who have tested positive or who have been determined to be in close contact with a person who has tested positive, please see the Student and Staff COVID-19 Dashboards, which are located on the School Safety and Security of our website and can be accessed by clicking <a href="here">here</a>.

As I shared with you last Friday evening, beginning on Monday, March 1, 2020, we will expand in-person instruction in accordance with our Restart of School Plan by transitioning our students in grades K-5 to Phase 3 and then students in grades 6-12 later in the month on Monday, March 15, 2021. Thus, on March 1st, all preschool through 5th grade students will be eligible to attend school for in-person instruction following the same early dismissal schedule as in Phase 2a&b on Mondays, Tuesday, Thursdays, and Fridays. Naturally, students in grades 6-12 Cohort C will also continue to attend school for in-person instruction on those days, just as they did in Phase 2a&b. However, on March 15th, all students in grades 6-12 will join the rest of our students in the district in Phase 3. Finally, as per our Restart of School Plan, until the end of this school year, parents will still have the option of having their child(ren) participate in full-time remote learning rather than in-person instruction. Conversely, at any time, parents can request from their child's principal that their child(ren) transition from full-time remote learning back to in-person instruction. However, in such cases, please note that it may take five calendar days for the change to be processed, as we may need time to make classroom and instructional preparations.

Nevertheless, today we will resume in-person instruction in Phase 2b for students in grades K-5 and Cohort C (preschool and MD/BD self-contained classrooms), and Phase 2a for students in grades 6-12. Therefore, today, Monday, February 22<sup>nd</sup> and Thursday, February 25<sup>th</sup> students in K-5 Cohort B will attend school for in-person instruction, while students in grades K-5 Cohort A do so tomorrow, Tuesday, February 23<sup>rd</sup> and Friday, February 26<sup>th</sup>. Likewise, students in grades 6-12 Cohorts A&B will participate in in-person instruction on Tuesday and Thursday. Naturally, students in Cohort C (preschool and MD/BD self-contained classrooms) will attend school for in-person instruction on Monday, Tuesday, Thursday, and Friday. Below please find the calendar for the rest of February and March.

If you did not have a chance to attend the Board of Education (BOE) Business Meeting held on Tuesday, February 16<sup>th</sup>, here is what you missed. Stephen Farley from Sayreville War Memorial High School (SWMHS) and Haley

Asseng from the Sayreville Middle School (SMS) began the meeting by providing their respective Student Council Representative to the Board of Education Reports. After that, Mr. Esposito expressed his opening remarks and Mr. Walsh shared district highlights. Ms. Hill, Business Administrator, began the presentation portion of the meeting by presenting the highlights from the district 2019-20 Comprehensive Annual Financial Report and Auditor's Management Report. Click on each to see them. The district then resumed

publicly reviewing and discussing the 2021-22 School District Budget with the following budget presentations: **Buildings and Grounds, Capital Projects,** and **Personnel**. The Board then moved the action items from the Superintendent's Report onto the Board Agenda and approved all of them. To see the Agenda click <a href="https://example.com/here">here</a>. Among other motions, on the Vision 2030 Finance and Infrastructure portion of the agenda, the Board approved the aforementioned 2019-2020 Comprehensive Annual Financial Report, which included the annual Auditor's Management Report as prepared by Suplee, Clooney & Company. It also approved a change order for the Direct Install Program to revise the total project costs to \$548,029.23. The project costs include an incentive of \$235,594.34 from the New Jersey Office of Clean Energy with the remaining project costs of \$312,434.89 to be paid through the funding of the district energy savings improvement project (ESIP) program. Likewise, the BOE approved a contract with McCabe Environmental Services LLC for environmental inspections related to the proposed ESIP project for an amount up to \$71,995 to be paid through the funding of the ESIP program. Lastly, the Board of Education awarded the district's power purchase agreement for Solar Photovoltaic Systems to EZnergy NJ LLC and Greenskies Clean Energy.

On the Personnel portion of the agenda, as well as other motions, with a heavy heart the Board of Education accepted the retirement of Linda Smith, School Counselor at the Samsel Upper Elementary School (SUES); along with the resignations of Doreen Herrick, Assistant Director of Nutrition and Food Service, and Lawrence Gates, Evening Buildings, Grounds and Security Supervisor. In addition, the BOE appointed new certificated and non-

certificated staff and approved the transfer of certificated and non-certificated staff members for the 2020-21 school year. Lastly, it hired Tier 3 and Flex Support Personnel for the 2020-21 school year to address the needs of struggling and disaffected learners.

During the Open Discussion portion of the meeting, Mr. Balka reviewed what was discussed during the last Finance and Infrastructure Committee Meeting. Likewise, Walsh did the same with regard to the last BOE Personnel Committee Meeting. Finally, Mrs. Bloom shared news from the Middlesex County School Boards Association.

The next meeting on **Tuesday, March 2<sup>nd</sup>**. During it, the district will more than likely ask the Board of Education to approve the 2021-22 Tentative School District Budget. A complete copy of the **February 16<sup>th</sup>** meeting minutes will be posted on the BOE Meeting Minutes page of the website once they are approved by the BOE during the next BOE Meeting on **March 2, 2021**.
