Talk Sup Week 30 Review and Preview

April 11, 2021

Good evening Sayreville! I hope you had a happy holidays and a relaxing spring break. Welcome to a special Sunday edition of *Talk Sup Review and Preview*.

Over spring break we received notification that three individuals from the Arleth School, two from the high school, two from the Samsel Upper Elementary School (SUES), one from a private preschool, one from the Transportation Department, one from the Food Services Department, and four from the Buildings and Grounds Department have tested positive for COVID-19. After conducting contact tracing in accordance with Center for Disease Control (CDC) and New Jersey Department of Health (NJDOH) guidelines, multiple individuals from Food Services and Buildings and Grounds were determined to be in "close contact" with the infected people and by this time should have been notified and directed to quarantine. For the most up to date information on the number of individuals who have tested positive or who have been determined to be in close contact with a person who has tested positive, please see the Student and Staff COVID-19 Dashboards, which are located on the School Safety and Security of our website and can be accessed by clicking here.

As you know, on Monday, May 3rd, we will transition to Phase 4 of our Restart of School Plan, which is essentially full school days of in-person instruction for five days per week. Thus, beginning then, all students will participate in full periods of instruction whether they are doing so remotely or in-person. In addition, there will no longer be "office hours." Nonetheless, parents will continue to have the option of having their child(ren) participate in full-time remote learning rather than in-person instruction until the end of the 2020-21 school year. Likewise, up until Friday, April 23rd, parents may request from their child's principal that their child(ren) transition from either full-time remote learning back to in-person instruction or vice versa. Prior to spring break, our principals informed the parents of their students about how they will be expected to communicate requests to change the learning environment of their child(ren) prior to April 23rd. However, after April 23rd, no changes to the learning environment (fulltime remote or in-person) will be accepted. Hence, if parents want to switch their child(ren) from remote learning to in-person learning or vice versa, they will have until April 23rd to do so and will be locked into that or their child(ren)'s current learning environment until the end of the 2020-21 school year. In addition, while we will still allow in-person students to access live-streamed lessons remotely, after April 23rd, unless students have been directed by the administration of their school to quarantine, if they are not present in school for instruction, they will be marked absent.

This week, <u>all</u> in-person learners in <u>preschool through 12th grade</u>, will continue to attend school for in-person instruction following the early dismissal schedule in accordance with Phase 3 of our Restart of School Plan. Below please find the calendar for April and May.
