Good afternoon Sayreville! I hope you had a nice and relaxing weekend, and a happy and most enjoyable Mother's Day. Welcome to another edition of *Talk Sup Review and Preview*. As per my Off Day Update email to the community yesterday (click here to see it), not only did Governor Murphy close all schools in New Jersey for in-person instruction until the end of the academic school year, on Friday afternoon he and the NJDOE banned in-person or vehicle parade graduation and promotion ceremonies.

In fact, they indicated in a **broadcast memo** that the only type of ceremony that will be permitted will be those that are virtual or pre-taped. While we are deeply disappointed by this decision, we have already begun developing the best possible plans for a virtual and/or edited pre-taped high school commencement ceremony for our graduating seniors on June 11th and promotion ceremony for our 8th graders on June 10th. More information on the June 11, 2020 high school graduation and the June 10, 2020 8th grade promotion ceremony will be sent out within the next week or two by the administration at each respective school. Finally, as you will read

a little further in this edition, during the Board of Education (BOE) Business Meeting last Tuesday, the BOE approved the rescheduling of the Senior Prom to Friday, July 31st at the Heldrich Hotel and Conference Center in New Brunswick. Although there is a good possibility that we will still not be permitted to hold it, we wanted to schedule it just in case. As you will also read further down in this edition, last Tuesday the Board also approved a temporary revision to BOE Regulation # R6147.1 Student Assessment, Reporting, and Reporting of Grades for students in grades 6-12 during the time of virtual instruction. Below please find the changes. Please note the bullet that is highlighted.

- The third marking period quarterly assessment is eliminated.
- The 15% normally allocated to the third quarterly exam grade is redistributed to other categories depending on individual departments.
- The lowest grade on the report card for the third marking period will be a 60.
- The fourth marking period quarterly assessment is eliminated.
- Classwork/homework will be 20% of the grade and 80% will be other assessments determined by each department in the fourth marking period.
- The third marking period grade is the baseline for the fourth marking period.
- If a student satisfactorily completes work and participates in distance learning, the student's fourth marking period grade will not be lower than the baseline.
- If a student does not satisfactorily complete fourth marking period work, their fourth marking period grade may drop below a 60% in commensuration with their effort.
- If the student's fourth marking period grade is higher than the baseline, the student will earn the higher grade for the fourth marking period.

As also noted in my Off Day Update last Saturday, we have also begun planning the process for closing out the school year, which will include providing staff, parents and/or students with an opportunity to collect their personal

belongings, including medications, and to return all district resources. To prepare for this, on May 18th our buildings and grounds staff will be returning to the district to clean and sanitize our buildings. On May 26th, our administration, secretarial staff, and campus security monitors will return to assist in the process of collecting resources and distributing personal items. In fact, we will begin doing so for 12th graders at the high school the week of May 26th. Likewise, we will do the same for 8th graders at the middle school during the week of June 1st. We will complete this process during the week of June 8th for all remaining students at the high school and middle school, along with all students in the upper elementary school, K-3 elementary schools, and preschool. Schedules and specific details for these plans will be predicated on the social distancing requirements, particularly the number of people permitted in a given space at a time. Thus, once we have a better understanding of what that will be, the administration at each of our schools will send schedules and specific details, which will naturally include the social distancing guidelines that will be required, to staff and students.

As they have been since the beginning of the pandemic, our amazing group of Operation BStrongSayreville volunteers once again prepared and delivered over 3,000 meals, many devices, countless student work packets, and toilet paper, paper towels, and tissues for anyone who needed such last week. This week, we will once again be delivering breakfast/lunches on just Mondays and Wednesdays. Thus, we will be asking parents to order for two days at a time for Monday and Tuesday, and three days at a time for Wednesday, Thursday, and Friday. For more information pertaining to the ordering and delivery of meals and supplies this week, see my **BStrongSayreville Off Day Update email**, which I sent to the community on Saturday evening. As per it, remember that we are also allowing community members to refill **one 12-ounce** container of hand sanitizer in the main vestibule of SWMHS from 8 am – 12 pm on Mondays and Wednesdays.

The Board then immediately moved the action items from the Superintendent's Report onto the Board Agenda and approved all of them. To see the Agenda click here. To see the Agenda Addendum click here. Finally, to see the video of the meeting, click on each part Part 1 and Part 2. Along with other motions, on the Finance and Infrastructure portion of the agenda, the Board of Education approved the 2020-21 School District Budget in the amount of \$95,541,326, which includes a local tax levy of \$64,418,966. To see the User Friendly version

In addition, it accepted the New Jersey Department of Education approval of the 2020-2021 Preschool Expansion Aid (PEA) Plan and Budget, and the submission of a revision to its budget. Among other motions, on the Student Achievement portion of the agenda, the Board approved the rescheduling of the Sayreville War Memorial High School (SWMHS) Senior Prom to Friday, July 31st from 6:00PM to 11PM at the Heldrich Hotel and Conference Center in New Brunswick. Additionally, on the Governance portion of the agenda, the BOE approved a revision to the 2019-20 School District Calendar, which essentially eliminated the two additional days (181 and 182) of instruction unique to Sayreville and therefore ends the school year for students on June 11th and for teachers on June 12th. R6147.1 Student Assessment, Reporting, and Reporting of Grades for students in grades 6-12 during the time of virtual instruction. Finally, as well as other motions, on the Personnel portion of the agenda, the Board accepted the retirements of Robert Lindemann, Teacher at the Samsel Upper Elementary School (SUES), Diedre LeBlon, Speech and Language Therapist at SUES, Deborah Esposito, Paraprofessional at SWMHS, John Forestano, Custodian at SWMHS, and Debra Palmer, Custodian at the Truman Elementary School.

During the Open Public Comment portion of the meeting, a parent of a students expressed concerns regarding the posting of the vacant SWMHS Head Basketball Coaching position. During the open BOE discussion portion of the meeting, Ms. Kenney reviewed what was discussed during the last BOE Student Achievement Committee Meeting, as did Mr. Esposito, with regard to the last BOE Finance Committee Meeting, and Mr. Callahan with regard to the last Personnel Committee Meeting. Finally, Mrs. Bloom reviewed news from the Middlesex County School Boards Association.

The next meeting will be held on **Tuesday, May 19**th at **7:30 pm**. During it, the district and BOE will recognize, honor, and celebrate all our 2019-20 Governor's Educators of the Year, as well as this year's Sayreville Education Association Support Professionals of the Year. Since we will still probably be living under quarantine then and thus not be permitted to leave our homes for anything that is not considered "essential," we will hold this meeting virtually.
