#### Talk Sup Week 20 Review and Preview

January 22, 2018

Good morning Sayreville! I hope you had a relaxing weekend and enjoyed the mild temperatures. Welcome to another edition of *Talk Sup Week Review and Preview*.



If you did not have a chance to attend the Board of Education (BOE) Business Meeting held on Tuesday, January 16<sup>th</sup>, here is what you missed. Ms. Hill, the District Business Administrator and Board Secretary, began by introducing the auditor of record for the BOE from Samuel Klein & Company, who reviewed the <u>2016-17 Comprehensive Annual</u> <u>Financial Report (CAFR)</u> and <u>Auditor's Report</u> and noted that it contained no

recommendations for corrective action. Click on each report to view them. After that, I introduced, and reviewed with the Board the <u>2017-18 School District Goals</u>, which they would approve later in the meeting. However, after doing such, Mr. Biesiada and the Board requested that another School Culture and Climate goal be included to address the increase in harassment, intimidation, and bullying (HIB) incidents. Click on the goals to see them. Thus, the Board will be asked to approve a revision of those goals during the upcoming February 7<sup>th</sup> BOE Workshop Meeting.

The Board then moved the action items from the Superintendent's Report onto the Board Agenda and approved them all. To see the Agenda click <u>here</u>. To see the Agenda Addendum click <u>here</u>. Among other motions, on the Vision 2030 Finance and Infrastructure portion of the agenda, the Board approved the above mentioned Comprehensive Annual Financial Report for the 2016-17 school year. In addition, it approved the submission of an amended application for funding under the Individuals with Disabilities Education Act (IDEA) in the total amount of \$1,535,827 for the period July 1, 2017 through June 30, 2018.

Furthermore, on the Student Achievement portion of the agenda, the Board approved of students from Sayreville Middle School (SMS) and Sayreville War Memorial High School (SWMHS) to participate in the 2017-18 Middlesex County Arts Middle and High School Programs. It also approved co-curricular activities, including but not limited to the **revised** Arleth School Science Family Fun Night on Friday, February 9, 2018 and the Project Before Unified Sports Soccer Game to be held on Tuesday, February 6, 2018. On the Governance portion of the agenda, the BOE approved the revised Teamsters Local 469 Holiday Schedule for the 2017-2018 school year and the aforementioned 2017-18 School District Goals.

Finally, on the Personnel portion of the agenda, as well as other motions, the Board of Education appointed new certificated and non-certificated staff for the 2017-18 school year. Additionally, it approved the salary adjustments for the certificated and non-certificated members of the Sayreville Education Association, including replacement teachers, for the period from July 1, 2017 through June 30, 2020, effective July 1, 2017. Similarly, the BOE also approved the salary adjustments for the Confidential Secretaries and non-certificated personnel not in a collective bargaining unit for the 2017-18 school year, effective July 1, 2017 through June 30, 2018. During the public comment portion of the meeting, a community member commented on the monthly HIB report and expressed that parents need to be better educated about HIB, particularly the parents of perpetrators. She also agreed with Mr. Biesiada that the district should be doing more to better educate the students on it.

During open discussion, Mr. Esposito reviewed what was discussed during the last BOE Finance and Infrastructure Committee Meeting, as did Mr. Callahan with regard to the last BOE Personnel Committee Meeting. Mrs. Batko questioned Mr. Ciak and commented about the manner in which BOE members were assigned to committees this year. Likewise, Mr. Balka requested to be removed from a committee due to a conflict of interest. After that, the Board reviewed and discussed all supply (600) expenditures budgeted in the proposed 2018-19 School District Budget. To see them, click here.

While I was unable to attend, last week several staff members led by Dr. Cynthia DeFina, Supervisor of Special Education, Marcus Ivy, SWMHS Physical Education Teacher, and Melissa Ciampa, SMS Special Education Teacher, accompanied over twenty students from SWMHS and SMS on a trip to the Unified Sports Winter Shore Youth Summit. If you are not aware of what Unified Sports are, it is a program which brings youths with and without intellectual disabilities together through education and sports to create school communities of acceptance and respect. During this Summit the

students shared their feelings on inclusion and exclusions, as well as ways to accept others more. In addition, our Sayreville students worked together with their peers from Old Bridge on ideas about games,



fundraising, and activities for a club. If fact, they not only developed posters to promote Unified Sports, they also shared the steps that they would need to take in order to make their ideas become a reality. According to Dr. DeFina, it was moving to hear our students share their accounts of how Unified Sports has changed their lives creating friendships that they never would have previously had the opportunity to make. We congratulate and commend all of our



students and staff members who have made the Sayreville Unified Sports program such a hallmark of our district.
