Talk Sup Week 3 Review and Preview

September 25, 2017

Good morning Sayreville! I hope you had a relaxing weekend. Welcome to another edition of *Talk Sup Week Review and Preview*. If you did not have a chance to attend the Board of Education Business Meeting held on Tuesday, September 19th, below please read what you missed.

Mr. Ciak began the meeting by giving the members of the public the opportunity to ask questions, express, concerns, or share their feedback regarding anything pertaining to the opening of schools. Members of the Association of Sayreville Indians of America (ASIA) asked the Board to allow Dr. Labbe to exercise his authority to defer from BOE policy so that their group could use Sayreville Auxiliary Police rather than actual police officers for an upcoming event that they will be leasing the district's facilities for. The Board almost unanimously agreed to do so. After that, Dr. Labbe provided a summary of the transportation problems that we experienced since the beginning of the school year. When he was finished, several community members expressed their concerns about bussing, as well as their appreciations for the district's responsiveness. Lastly, several community members inquired about and expressed their concerns over the new Grades 3-5 Standards-Based Report Cards.

Dr. Labbe began the presentation portion of the meeting by inviting Mr. David Knaster, Director of Special Services, to introduce the teacher and parent leaders of Sayreville PROUD, our special education parent advocacy group. They, along with Mr. Knaster, shared with the Board and public what PROUD is and how it serves the children with disabilities and their parents in Sayreville. After that, Dr. Labbe asked Mr. Glock-Molloy, Assistant Superintendent of Information, Technology, and Operations, to give a presentation on the district's 2016-17 harassment, intimidation and bullying (HIB) self-assessment ratings and Cycle 2 investigations, training, and programs data. The Board then moved the action items from the Superintendent's Report onto the Board Agenda and approved them all. To see the Agenda click <u>here</u>. To see the Agenda Addendum click <u>here</u>. Among other motions, on the Vision 2030 Finance and Infrastructure portion of the agenda, the Board approved resolutions authorizing the use of the "competitive contracting" procedures to solicit proposals for the purchase of financial and student information software. Additionally, it awarded the bid for the partial window replacement project at the Arleth Elementary School to the 1st Westco Corporation, which was the lowest bidder.

Furthermore, on the Student Achievement portion of the agenda, the Board approved co-curricular activities, including an October 24th Samsel Community Night and the November 2nd PROUD Resource Fair. The BOE also approved the 2017-18 Sayreville War Memorial High School (SWMHS) Activities Calendar. Likewise, on the Governance portion of the agenda, the Board approved the submittal of the Statement of Assurance Regarding the Use of Paraprofessional Staff (School Aides) for the 2017-18 school year and a settlement

agreement between the Sayreville Education Association and the Board on SEA Grievance 2015-75 DCRP Deductions.

We congratulate and/or welcome them to our school community.

During open discussion, Mr. Esposito reviewed what was discussed during the last BOE Finance Committee Meeting, as did Mr. Biesiada, Ms. DePinto, and Mr. Walsh with regard to the last BOE Buildings and Grounds, Student Achievement, and Personnel Committee Meetings respectively. In addition, Mr. Macagnone shared some comments about the progress our district has made with regard to school security. Finally, Mrs. Bloom reviewed what was discussed during the last New Jersey School Boards Association Board of Directors Meeting, and shared some positive feedback about the special services that our district provides to our students with disabilities.
