SAN MATEO FOSTER CITY SCHOOL DISTRICT 2021-2022 BUDGET General Fund Highlights June 24, 2021

The 2021-2022 general fund budget is based on the most current information and best estimates available to the District at this time. As a "basic aid" or community-funded District, local property taxes continue to be the budget driver and account for seventy-eight percent of all revenue. Secured property tax growth is forecast to be four percent, reflecting the continued, positive residential and commercial assessed valuations within our district boundaries. Revenue adjustments are included in the budget associated with the Governor's May Revise. The budget reflects an increase in Special Ed funding from \$625.00 to \$650.31 per ADA. The budget reflects the remaining fifty percent of the AB86 funding. The budget does not include the Elementary and Secondary School Emergency Relief Fund (ESSER) III and Governor's Emergency Educations Relief Fund (GEER) II funding as of yet because the budget has not been finalized. We anticipated providing revenue revisions in August 2021 and expenditure adjustments at First Interim.

The Governor's budget proposes increases in funding for new and existing programs such as Summer and Afterschool programs, Universal Transitional Kindergarten, and Child Care and Preschool funding rates. As the budget is finalized, we will receive more detail regarding these proposals and reflect them in the first Interim.

The budget includes the following expenditure adjustments aligned with the planned LCAP:

- Decreases in FTEs associated with a reduction in enrollment
- 50% of planned AB 86 ELO and IPI expenditures (unspent 2020-2021 revenues and remaining apportionment will be budgeted at 1st Interim)
- Step and Column Increases
- Health and Welfare Increases
- Statutory Benefit Increases
- Property and Liability premium increases
- Decreases in Books and Supplies purchases primarily associated with a reduction in LLMF one time funds in 2020-2021
- Changes in Contracted Services associated with a decrease in Title fund carryover, lottery carryover, increase in Special Ed program and decreased planned expenditures related to donations (these will be booked at first Interim after receipt of donations).

The budget does not include salary increases for any employee group. The negotiations have not been concluded for the fiscal year 2021-2022.

The budget does not include any anticipated increased costs for the new school in North Central.

Fund Balances

The fund balances for the adopted budget reflect an increase in fund balances compared to the 2020-21 second interim report. The increase in fund balances is associated with increased revenue such as property tax, receipt of the ESSER II, and AB86 funding. In addition, expenditures have been adjusted to reflect the projected estimated actuals for the fiscal year 2020-21.

Multi-Year Projection

The multi-year projection budget reflects a deficit in each of the three fiscal years to spend down one time reserves but maintains a balanced budget in each of the three years. Although the District is deficit spending, the District does not have a structural deficit. 2.5% of the salaries and statutory benefits for SMETA are funded from Measure V.
