EXECUTIVE SUMMARY

2021-22 Second Interim Overview

This report represents the snapshot of January 31, 2022 budget projections of all revenues and expenditures for the current year as well as two subsequent fiscal years.

Governor Gavin Newsom released his proposed January State Budget and subsequent trailer bills on January 10, 2022. It is time for LEAs to adjust revenues and expenditures, and begin projecting the ending balances for the funds and resources at Second Interim. With that, the Second Interim report covers the period of time from July 1 through January 31, and must be submitted to the county office of education (COE) no later than March 17 (45 days after the close of the reporting period per Education Code Section [EC §] 42131[a]).

Below are the **major changes** from the First Interim Budget to Second Interim.

1. **Proposal for ADA:** Beginning in 2022-23, and for future years, would amend EC § 42238.05(a)(1) and allow a third option for funded ADA which would use the actual ADA from the prior three years. If enacted, this would allow a school district in 2022-23 to be funded on the greater of the following:
 - i. Actual ADA from 2022-23
 - ii. Actual ADA from 2021-22
 - iii. Average ADA based on actuals from 2019-20, 2020-21, and 2021-22
2. **Cost of Living Adjustment (COLA):** 2022-23 from 2.48% to 5.33%, 2023-24 from 3.11% to 3.61%
3. **Local Control and Accountability Plan and Supplement (LCAP):** LEAs are in the second round of adopting a Local Control and Accountability Plan (LCAP) after the one-year abeyance for the 2020-21 fiscal year. The additional wrinkle this year is the LCAP Supplement that must be considered by the governing board no later than February 28, 2022.
4. **Early Childhood Education:** The proposal includes additional investments in early childhood with COLA and funding for Universal Transitional Kindergarten (UTK). Please note there is no additional UTK for basic aid districts.
5. **Special Education:** The 2022-23 budget proposals significantly build on special education funding augmentations including COLA and the funding exhibits for each LEA will be provided by the CDE, and SELPAs must report the amount of funding generated by each member LEA no later than 30 days after receiving their apportionment.
6. **Universal School Meals:** grants for school kitchen upgrades and training, additional support to School Breakfast and Summer Meal Start-Up and Expansion grants.

General Fund Overview

General Fund (Fund 01): This is the chief operating fund for the District. It is used to account for the ordinary operations of the District. All transactions, except those required or permitted by law to be in another fund, are accounted for in this fund. In the General Fund, there are Unrestricted and Restricted revenues and expenditures.


General Fund Unrestricted: Unrestricted funds are monies received that are not restricted in their use. The District can spend unrestricted monies on those programs that fit and meet its priority.

General Fund Restricted: Restricted funds account for those projects and activities that are funded by external revenue sources that are legally restricted or restricted by the donor to specific purposes. For example, special education funds are restricted. They can only be spent on students with identified special needs and in the manner outlined in state and federal law.

LCFF Sources (Object 8010-8099): \$129,512,228 (Unrestricted: \$121,902,797; Restricted: \$7,609,431)

Being a Basic Aid school district, LCFF revenues mainly come from property taxes, state aid, Education Protection Account, and community redevelopment funds. There is no adjustment made at the 2nd Interim. The LCFF sources constitute 73.4% of the District total revenues.

Federal Revenue (Object 8100-8299): \$7,780,347 (Unrestricted: \$0; Restricted: \$7,780,347)

This represents 4.4% of the total general fund revenues. Compared to the 1st Interim, there is an increasing of \$1,814,865. The changes are listed as follows:

Title I: (\$35,075)

Title II: (\$540)

Every Student Succeeds Act: \$75

Other Federal: \$1,850,405

Other State Revenue (Object 8300-8599): \$19,637,035 (Unrestricted: \$2,308,974; Restricted: \$17,328,061)

Other State Revenue represents 11.1% of the total general fund revenues. Compared to 1st Interim, it increases by \$3,245,425. The changes are listed as follows:

After School Education and Safety (ASES): \$53,050

Other State (ELO related grants): 3,192,375

Other Local Revenue (Object 8600-8799): \$19,532,886 (Unrestricted: \$6,317,384; Restricted: \$13,215,502)

This represents 11.1% of the total general fund revenues. The projected revenues are up by \$883,258, compared to 1st Interim. The changes are listed as follows:

Student Unity Day COE Program: \$2,000 (Unrestricted)

Mail Service: \$1,148 (Unrestricted)

Lease and rental: \$257,453 (Restricted)

Other Local (Site Driven): \$622,657 (Restricted)


Interfund Transfers In (Objects 8900-8929): \$187,042 (Unrestricted: \$0; Restricted: \$187,042)

It is about 0.1% of the total general fund budget. The amounts come from fund 12 to support Parent Involved Projects in general fund (resource 9392 and 9393). There is no adjustment made for the 2nd Interim.

Overall, the Second Interim total revenues are higher than the First Interim budget by \$5,943,548.

Certificated Salaries (Object 1000-1999): \$73,328,685 (Unrestricted: \$56,148,336; Restricted: \$17,180,349)

Certificated salaries are salaries for positions that require a credential or permit issued by the Commission on Teacher Credentialing. Certificated salaries include teachers, counselors, psychologists, and certificated management. Compared to the 1st Interim budget, the certificated salaries are decreased by \$1,168,775 as the result of to be in alignment with what the best projections which include capturing the savings from unfilled or late hired positions. At the 2nd interim, total certificated salaries represent about 41.8% of the total expenditures.

Classified Salaries (Object 2000-2999): \$19,369,058 (Unrestricted: \$10,568,845; Restricted \$8,800,213)

This classification represents the salaries paid for the positions that do not require a credential or permit issued by the Commission on Teacher Credentialing. The positions in this classification are library/media staff, office staff, clerical assistant, district office staff, instructional aides, and maintenance and operations staff. It is about 11% of the total expenditures. Compared to the 1st Interim,

the budget is increased by \$52,178 mainly is as the result of the adjustments made for instructional aides and hourly people.

Employee Benefits (Object 3000-3999): \$38,959,620 (Unrestricted: \$22,488,990; Restricted: \$16,470,630)

Employee benefits include retirement plans (State Teachers' Retirement System-STRS, and Public Employees' Retirement System-PERS), Health and Welfare benefits, Other Post-Employment Benefits (OPEB) Annual Required Contributions (ARC), and payroll related statutory costs such as Workers' Compensation, State Unemployment Insurance, FICA, and Medicare. It is about 22.2% of the total expenditures. The payroll related statutory rate for certificated employees is 23.36% and for classified employees is 35.55%. Compared to the 1st Interim, it is decreased by \$663,198 as the result of savings on salaries. Employee benefits are salaried driven, if salaries go down so as benefits.

Books and Supplies (Object 4000-4999): \$9,685,280 (Unrestricted: \$3,694,745; Restricted \$5,990,535)

These accounts are for expenditures related to curriculum books and supplies, other reference materials, and non-capitalized classroom equipment. It represents 5.5% of the total expenditures. Compared to the first interim, it is about \$2M lower as the result of savings from the textbook adoption. At this point, we do not anticipate the textbook adoption will occur by June 30, 2022.

Services and Other Operation Expenditures (Object 5000-5999): \$33,071,510 (Unrestricted \$10,167,170; Restricted \$22,904,340)

These accounts are for expenditures for services, rentals, leases, maintenance contracts, dues, travel, insurance, utilities, legal, and other basic operating expenditures. The expenditures in category represent 18.8% of the total expenditures. Compared to the first interim budget, it increases by about \$1.3M. The increases are the results of budget reallocation and adjustments (due to additional revenues) made to address the needs of the District.

Capital Outlay (Object 6000-6999): \$75,173 (Unrestricted: \$19,947; Restricted: \$55,226)

Capital Outlay is for expenditure that exceeds \$5,000 as value and is subject to depreciation. Compared to the first interim, the second interim budget reflects an additional amount of \$8,898. The increase is for classroom furniture.

Total Other Outgo and Indirect Costs (Object 7100-7499): \$901,958.

The major expenditures include the net of tuitions to COE for excess costs (Special Education), and indirect costs. It is about 0.5% of the total expenditures. Compared to the first interim budget, it goes down by \$43,594 as the result of indirect cost went down.

Transfer Out (Object 7600-7629): \$119,650 (Unrestricted: \$0; Restricted: \$119,650).


Compared to the adopted budget, this represents a suspension of transfer to Deferred Maintenance Fund (fund 14) for the current year. This category represents 0.1% of the total expenditures. There is no change made for the Second Interim.

Fund Balance: \$61,372,590 (Unrestricted: \$38,159,361; Restricted: \$23,213,229)

The Second Interim fund balance is increased by \$8.5M compared to the First Interim budget. The unrestricted fund balance increases by about \$4.7M and restricted fund balance increases by about \$3.8M. The restricted fund balance will be carried over into 22-23 to spend. The unrestricted fund balance will be set aside for the required reserve, vacation payout, reserve for P&L deductible, mold

insurance, one-month payroll due to revenues being deferred at all levels (Federal, State, and Local), future textbook adoptions, technology gears replacement and the reserve from prior year allocation (unspent) due to COVID and delayed our spending plans.

Cash Flow

We are required to submit a 24-month Cash Flow Worksheet. Based on the cash flow analysis, the district will not experience any cash shortage within a 24-month period for the General Fund.

Other Funds Overview

The 2020-21 First Interim, Beside General Fund, there are additional ten funds in the District accounting system. The District's funds include:

- Child Development Program (Fund 12)
- Cafeteria Special Revenue (Fund 13)
- Deferred Maintenance (Fund 14)
- Special Reserve Other Than Capital Outlay Projects (Fund 17)
- Building (Fund 21)
- Capital Facilities (Fund 25)
- Special Reserve for Capital Outlay Projects (Fund 40)
- Other Enterprise Fund (Fund 63)
- Retiree Benefits Fund (Fund 71)
- Foundation Private-Purpose Trust Fund (Fund 73)

CHILD DEVELOPMENT PROGRAM (Fund 12): This fund is used to separately track federal, state, and local resources used to operate the Child Development Programs. The program includes State Preschools and Federal Child Care. Compared to the Adopted Budget, the revenue improves by

\$92,766 due to state revenues improving by \$12,760 and local revenues improving by \$80,006. The expenditures increase by \$182,682 mainly for salaries and benefits adjustments to reflect the salaries improvements for the 2021-22. The projected ending balance is \$922,344.

CAFETERIA SPECIAL REVENUE (FUND 13): This fund is used to account separately for federal, state, and local resources to operate the food service program (Education Code sections 38090 and 38093). The principal revenues in this fund are: Child Nutrition Programs (Federal) Child Nutrition Programs (State) Food Service Sales Interest All Other Local Revenue. The Cafeteria Special Revenue Fund (Fund 13) shall be used only for those expenditures authorized by the governing board as necessary for the operation of the District's food service program (Education Code sections 38091 and 38100). Compared to the 1st Interim budget, the projected revenues increase by additional \$104,805 and there is no change for expenditure adjustment. The projected ending balance is \$3,424,817.

DEFERRED MAINTENANCE (Fund 14): This fund historically has been used to account for state apportionments and the District's contribution for deferred maintenance purposes. There is no budget adjustment made for the 2nd Interim reporting period. The projected ending balance is \$5,617,298.

SPECIAL RESERVE FOR OTHER THAN CAPITAL OUTLAY PROJECTS (Fund 17): This fund is used for the accumulation of general fund monies for general operating purposes to be used in future. Fund 17 is not for capital outlay. There is no budget adjustment made for the First Interim. The projected ending balance is \$885,165.95.

BUILDING (Fund 21): This fund exists to account for proceeds from the sale of bonds and may not be used for any purposes other than those for which the bonds were issued. The general obligation bond represents the voters approved Measure X, and T. There is no budget adjustment made at the 2nd Interim reporting period. The projected ending balance is \$78,729,462.

CAPITAL FACILITIES (Fund 25): The purpose of this fund is to account for monies received from fees levied on developers (aka Developer Fees), or other agencies as a condition of approving a development. The interest earned in this fund is restricted to this fund. The expenditures in this fund are restricted to the purposes specified in agreements with the developer or specified in Government Code. Government Code requires that an annual report of income and expenditures from developer fees and the beginning and ending fund balances in this fund be made available to the public within 180 days, after the end of each fiscal year. Government Code 66001 requires a five-year report if there are any balances remaining in the Fund at the end of the prior year fiscal year. Compared to the 1st Interim budget, the revenue is increasing by \$250,000 for the developer fees projection and the expenditure is increasing by \$4,695 for the DSA fees for capital project. With that, the projected ending balance is \$5,609,447.

County School Facility Fund (Fund 35): The fund is established to account for new school facility construction, modernization projects and facility hardship grants, per Education Code. There is no budget adjustment made for the Second Interim. The projected ending balance is \$26,037.

SPECIAL RESERVE FOR CAPITAL OUTLAY PROJECTS (Fund 40): This fund provides for the accumulation of general fund monies for capital outlay purposes. This fund may also be used to account for other revenues specifically for capital projects. There is no any adjustment made for the 2nd interim period. The projected ending balance is \$16,333,582.

Other Enterprise fund (Fund 63): The fund is used to account for any activities for which a fee is charged to external users for goods or services. The district uses this fund to account for Fees Based Child Care Centers, Super CO-OP (Cafeteria consortia), and Fees Based Pre-K. At 2nd Interim, the revenues are adjusted up \$52,350 for rental and lease income and the expenditures adjusted up by \$35,392 to be in line with reality including adjustments for salaries, benefits, supplies, and services. The projected ending balance is \$3,988,765 which include \$638,928 for Super CO-OP and the remaining balance is for the child care.

RETIREE BENEFIT (Fund 71): The District uses this fund to account for retiree benefits. There is no budget adjustment for the 2nd Interim reporting period. The projected ending balance is \$26,344,472.

Foundation Private Purpose Trust Fund (Fund 73): This is to account for gifts or bequests per Education Code. It can only be spent for the specific purposes of the gifts or bequest. There is no budget adjustment made for the First Interim. The projected ending balance is \$150,844.
