RE: 11/13/19 Joint Superintendent Parent Advisory Council and Blue Ribbon Committee Meeting Follow-Up

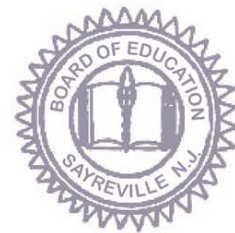
The following is a summary of the major agreements and items discussed during the joint Superintendent Parent Advisory Council and Blue Ribbon Committee Meeting held on Wednesday, November 13, 2019. To see all 2019-20 SPAC Agendas and Follow-Ups, including those in Spanish, click [here](#).

- Dr. Labbe began the meeting by thanking the PTOs, parent groups, and administrators for providing the time and venue to make over 17 Facilities Improvement Strategic Plan presentations to staff, parents, and community members during the month of October. In addition, he asked Mr. Jegou to provide an update on the traffic problem at the middle school during student and staff arrival in the morning. Mr. Jegou indicated that while there is still some minor congestion, things have improved significantly since the beginning of the school year.
- Dr. Labbe reviewed the preliminary results of the Facilities Improvement Referendum Survey that Sayreville Community members were asked to complete beginning on November 4th. After the presentation, Dr. Labbe facilitated a discussion on the next steps in the process, which would be for him to make his survey results presentation to the Board of Education and the public during the November 19th BOE Business Meeting before potentially asking the BOE to approve a referendum resolution on the December 17th BOE Business Meeting Agenda. After that, Dr. Labbe solicited ideas pertaining to potential marketing strategies that could be employed should the Board approve the referendum resolution on December 17th.
- Dr. Labbe notified the participants about the opening of 2020-21 full-day preschool and kindergarten registration on Friday, November 15th.
- Dr. Labbe informed the SPAC that all PTO or parent booster club fundraising plans for major monetary donations, particularly those that are used to improve school district facilities, such as playgrounds and air conditioning units, must be approved first by him prior to the commencement of fundraising.
- Due to the very short month of December this year and all that is going on across the district with regard to the upcoming holidays, our next joint meeting, which was scheduled to take place on **Wednesday, December 11th**, has been **cancelled**.
