LCPS works in conjunction with Lee County Pre-K to ensure that students do not have consecutive years with an inexperienced teacher. Teacher rankings are used to monitor the placement of children. We also communicate with Lee County Elementary and Twin Oaks Elementary in placing 3rd graders.</p>

Leveled Literacy Intervention has been purchased and is being used with students receiving reading intervention through the interventionists. Student progress is being monitored through progress monitoring data. Reading interventionists work extensively with students to improve specific reading skills and comprehension strategies. An interventionist addresses the specific needs of a particular child when regular instruction is not sufficient. Interventionists work with the teacher to design specific methods of learning that are most appropriate for the child.</p>
