Memo Regarding Student Interview/Photography/Video

Dear Students and/or Parents/Guardians,

A part of the communication efforts of the Davis School District (DSD) and Vista Education Campus (VEC) is to let the general public know about the educational activities occurring within the walls of our schools. The DSD Special Education Department and VEC, specifically, may at times videotape, photograph, or interview students at a school, community, or work-site activity and may want to use those photos in their offices or other publications.

At times the media may choose to highlight district or school work or activities (which may include community and work-sites). Reporters may contact the DSD or VEC regarding a story. We make every effort to work together with the media and to ensure that our efforts or viewpoints can be communicated. At DSD, we strive to promote our programs, as well as recognize our students' abilities and accomplishments. Consequently, DSD often invites reporters to the schools to cover educational activities and events, as well.

Because education is student-centered, the media often pursues stories that center on students. Therefore, we are requesting permission, in advance, for you (if you are your own guardian) or your student (if you are your student's guardian) to be interviewed, photographed, or videotaped.

IDEA provides for confidentiality of students in Special Education. Where VEC is a school with programs entirely for special education students, identification of a student as a VEC Student discloses that they are receiving Special Education services.
