Climate and Environment

The New Jersey Department of Education migrated to a new reporting system, the Student Safety Data System (SSDS), starting in 2017-18, which includes improved definitions, new reporting fields, and updated guidance for reporting incidents. Comparing current data to data from 2016-17 and earlier could lead to inaccurate conclusions in many reporting categories. In addition to the 2018-19 data below, NJDOE is required, under ESSA, to report on the most recent, publicly-available Civil Rights Data Collection (CRDC) data, which can be found on the <u>NJDOE School Performance webpage</u>.  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e. ATSI schools that do not meet exit criteria.
 - The NJDOE has not yet identified schools in this category as no ATSI schools have been in status for three or more years.

Annually, NJDOE will identify schools in the following federal category:

- Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):
 - · Schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

Important Note for 2020-2021: Due to the COVID-19 pandemic, New Jersey received waivers from the United States Department of Education (USED) in both March 2020 and March 2021 that waived accountability-related requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 and 2020-2021 school years. These waivers removed the requirements to:

- · Calculate indicator scores and summative scores for the 2019-2020 and 2020-2021 school years;
- · Measure progress toward long-term goals and measures of interim progress for accountability indicators for the 2019-2020 and 2020-2021 school years; and
- Identify schools for comprehensive and targeted support and improvement during the 2020-2021 and 2021-2022 school years (based on 2019-2020 and 2020-2021 data, respectively).

As a result of these waivers, any school that was identified for comprehensive or targeted support and improvement during the 2019-2020 school year will retain the same status for the 2021-2022 and 2022-2023 school years and continue to receive support and interventions from the NJDOE.

For the categories that are identified every three years, the last identification occurred in the 2018-2019 school year (based on 2017-2018 data) and the next identification was scheduled for the 2021-2022 school year (based on 2020-2021 data). As a result of these waivers, the next identification will be delayed until the 2022-2023 school year (based on 2021-2022 data) and all currently identified schools will be eligible to exit status at the end of the 2022-2023 school year.

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 or 2021-2022 school year as a result of these waivers. The next identification is scheduled for the 2022-2023 school year.

Highlights:	 We continue to implement the Fountas & Pinnell Classroom program to enhance and improve literacy skills. Our Response to Intervention program involves tier 2 supplemental small group instruction and morning literacy and math academies. Tier 3 intervention services include one to one instruction. The Stars Program, funded by the PTO and taught by teachers, offers students the opportunity to participate in enrichment activities such as STEM class, soccer, and basketball.

Courses, Curriculum, Instruction:	Our students use a number of programs including but not limited to Fountas & Pinnell Literacy Program, RAZKids, EnVision Math, and STMath. We offer a talented and gifted (TAG) program. We also offer Literacy and Math Academies and focus on improving our students' performance through the use of NJTSS for our at risk students. Students in need of more intensive interventions receive one to one Project Read instruction.
Before and After School Programs:	Our school and district has a partnership with Leading Edge Education which runs before and after school programs. The program provides homework help, academic support, character building programs and socialization skills. The program is supported by the company's unique curricula.
Staff and Professional Learning:	Currently, our teachers are developing their skills and receiving training on our new reading system through Fountas and Pinnell. Our teachers also worked, through a partnership with Teacher 2 Teacher, with a reading expert to coach our kindergarten through third grade teachers on best practices and strategies for improving our students' literacy skills. Staff is also receiving ongoing training on the implementation of Responsive Classroom.

Student Supports and Services:	Our students are provided with the following services, if needed: ELL instruction, pull out replacement instruction, and/or in-class support instruction for our special education population. NJTSS is provided for all of our struggling students. Our students also have a weekly visit from the school counselor, who spends 30 minutes a week with each class. The counselor also provides more individualized or specific sessions for our students needing socialization or coping skills.
Student Health and Wellness:	Eisenhower Elementary School offers breakfast in the classroom. Since providing breakfast in the classroom, we have seen an increase in the number of students eating breakfast. We also provide lunch for our students and 20 minutes daily of recess, as well as physical education class once a week for kindergarten and twice a week for grades one through three.
Parent and Community Involvement:	Our Parent Teacher Organization is central to our extra-curricular activities. The PTO helped to purchase 36 Chromebooks for the school. They also provided a number of educational programs for the students during the school day, including one on bullying prevention. The PTO also sponsors a monthly family activity to bring the students and their families out to enjoy a family friendly night. These include nights such as the Halloween Bash and the Mid-Year Carnival.

Facilities:	Our building houses a gymnasium/auditorium, an art lab complete with a kiln, a music room complete with sound proofing, a fully functioning library media center which includes a 36 computer laboratory, as well as a number of Chromebook carts. All the kindergarten and first grade classrooms have a bathroom in each room.
School Safety:	A campus monitor admits visitors into the building and checks identification. All visitors must pass through a metal detector and have all bags scanned. Sayreville PD is present during the school day as well. School administrator and campus monitor are able to communicate directly with Sayreville PD in case of an emergency.
Learning During COVID-19:	During the 2020-2021 school year, students participated in a synchronous hybrid instructional model which is outlined in our district restart plan. Virtual instruction followed a set schedule which mirrors in-person instruction. Teachers live streamed their in-person class to virtual students via WebEx or Google Meet.
