

Student Growth

Student growth is a measure of how much students are learning each year. Each student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7 that explains their progress compared to students who had the same test scores in previous years.

A student's SGP falls between 1 and 99 and can be grouped into three levels:

Low Growth: Less than 35

Typical Growth: Between 35 and 65

High Growth: Greater than 65

If the student growth percentiles for all students in the school are ordered from smallest to largest, the median student growth percentile (mSGP) for the school is the percentile in the middle of that list. The Proficiency Rate for Federal Accountability measures is the percentage of students that met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA results for 2018-19 include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. 

English Language Progress to Proficiency

A student's expected growth is based on the student's initial year proficiency level and student growth expectations are increased by equal intervals each year so that the student meets the proficiency cut score of 4.5 within five years. 

All students in grades 5, 8, and 11 will take the NJSLA-Science assessment. Students receive a score of Level 1, 2, 3, or 4 where levels 3 and 4 represent proficiency. 





As a result of these waivers, the next identification will be delayed until the 2022-2023 school year (based on 2021-2022 data) and all currently identified schools will be eligible to exit status at the end of the 2022-2023 school year.

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 or 2021-2022 school year as a result of these waivers. The next identification is scheduled for the 2022-2023 school year.

Parent and Community Involvement:

The Parent Teacher Organization helped to keep the SUES Community connected during the 2020-2021 school year by running contests via Facebook and helping to run the Halloween drive-thru parade. Facilities:

Samsel was a small elementary school for years before being rented out to the county. With an increase in district enrollment, the school was renovated and opened as an upper elementary school for all of Sayreville's 4th and 5th grade students in September 2004. The facility includes: a large gymnasium with A/C, stage & bleachers, cafeteria (A/C), media center/library (A/C), 3 computer labs (A/C), two science labs, auxiliary gym and classrooms with dividers to accommodate various settings.

Technology and STEM:

Technology is incorporated on a daily basis through the use of Smartboards, Touch TVs, Chromebooks and/or iPads. Programs such as Achieve 3000, RAZ kids, IXL and STMath help to supplement the curriculum. Students participated in STE(AM) clubs and the Communication Club during the Spring of 2021.



Learning During COVID-19:

Students in self-contained programs began to return to in-person instruction in October of 2020. In mid-November, additional students began to return to in-person instruction as teachers used synchronous instruction to educate students who remained home and those in-person. The school's wellness team met occasionally to keep abreast of best practices in supporting one another and the community. At-risk students were afforded the opportunity to be a part of a Summer Accelerated Learning Program. Students with special needs were afforded the opportunity to take part in Camp XL (ESY program).
