II. Student Achievement Report

A. KPREP Data Review

Overall score, McBrayer received a 3 star review. McBrayer was 2 points away from being a 4 star school. McBrayer was high in elementary reading scores.

Growth indicator for reading and math showed high scoring.

B. FALL MAP Data Review

K scored 51% at or above grade level in reading and 55% at or above in math. 1st grade scored 47% at or above in reading and 58% at or above in math. 2nd grade scored 52% at or above in reading and 55% in math. 3rd grade 42% at or above in math and 51% in reading. Will take a look at 3rd grade MAP to determine RTI groupings. Continue conversation with 3rd grade teachers during PLC. Look into IXL math for 3rd grade. 4th grade 52% at or above in reading and math 53% at or above. 5th grade 56% at or above in reading and 56% at or above in math.

C. RTI Dibels Reports

Most grade levels were at 50% or above grade level. Students had difficulty with blending all sounds together. K composite was 51% and worked on first sound fluency. 2nd Grade composite was 51%. ORF 49% at benchmark or above. 3rd grade 43% at or above with ORF. Focus on Fry words and fluency passages. 4th grade and 5th grade had over 50% at or above benchmark.

A. Writing Policy Rubric

State is changing writing policy. Reviewed Determination of Writing Policy and the Writing Document Rubric. The writing policy must be completed by December and uploaded for state review. The committee will be reviewing the writing policy and completing an updated policy for McBrayer. Discussion of developing an ad hoc committee for the revisions occurred.
